Dear Pfizer Counsels,

As instructed by this court prior to a temporary restraining order being presented, it first has to be submitted to the defendants for Pfizer at Davis Polk. Attached here is a copy of the actions filed and pending in Switzerland by Mr. Pascal Najadi. Like Panama, Switzerland exercised the Pfizer vaccine lockdown mandate and QR code in [quid pro quo](#) bases that limited and deprived its citizens in various forms, including lockdowns.

Pfizer gained sales on the mandate. Pfizer, a US corporation based in the United States of America, violated US federal and state laws and others in the United States; the only Covid-19 mandate in place is because of prior contracts signed by Medicaid and Medicare workers; [CMS](#).

1) The CMS contract should have been nullified as CMS workers were unacquainted with the clauses and, therefore, fraudulent

Najadi claimed in his interview with Fuellmich, "Now informed consent is very important in Switzerland too. I have filed criminal charges against the two doctors in Switzerland who

put the needle into my body of a known toxic, untested clinically, experimental, Nuremburg code violating substance without informing me about potential risks on the Pfizer website; heart attack, thrombosis, turbo cancer, etc., and then there should be a line, where one would sign, do you understand the risks and then entered into medical history.”

Najadi continued, “So because there was no mandate in the US or QR code imposed on people, Switzerland had no right to do that, and Pfizer, through the QR code and vaccination program in that country, gained profits. It’s a US company and a US product. The US laws and regulations apply.

Today, we made a Twitter press statement regarding this US Supreme Court case. Here I sit – tears streaming – nearly sobbing – I feel alone – but am I?

The aloneness began when I was mocked for wearing a mask in a small town long before anyone else was. “Here comes a masked bandit,” smirked a fellow customer over his shoulder to the clerk as I entered and he exited.

I have come full circle – from being very alone on one end of the spectrum of “covid” to where I sit today.

I’m typing this from my computer desk in what used to be the kitchen in the very home where my husband and his father both grew up. The home has been remodeled to fit our family’s lifestyle needs.

My farmer husband is skilled in many ways, so we did the majority of the work ourselves over many years. Most of his time is spent as a grain farmer. He’s very good at what he does. I’m the support crew. The sheep we kept to keep the creek area down were sold off nearly thirty years ago.

I’ve been blessed to be a stay-at-home wife and mom all of our nearly 35-year marriage. We homeschooled our children all the way through. They are now grown.



We now grandparent six really special kiddos ages two months to seven years of age. They are spread all over the country, but our century farm here in Iowa often draws them home.

## **How I believed in it all**

In January 2020, I got a bad cold with laryngitis and connected with a private researcher I'd found in other groups regarding EMFs a few years before. She was all about taking ascorbic acid and melatonin for "covid" and all health issues actually. I followed her research carefully into the world of studying the pandemic from the side of virology and immunology. I listened to about four hours per week of the podcast "This Week in Virology" for about 10 months.

I read tons of studies and articles about how "covid" was working in our bodies and how bad it was from the "scientific" and "medical" perspective. At first I only understood about 5% of what they said in the podcast and the studies.

I felt driven. I knew, somehow, it was very important for me to learn. I felt out of my league. My degree is in education.

Over time I grew to enjoy this team of virologists and immunologists and could maybe understand about 50% of what they said.

I have chronic low white count and other chronic undiagnosed issues, likely due to lifestyle issues along with childhood trauma plus EMFs. I've worked long and hard on my health, but I was obviously concerned about what my body would do if it got "this illness". I wore masks and stayed home LONG before anyone in my corner of a rural state.

As I studied, I kept getting videos from close friends and family to review that seemed to be in the conspiracy theory camp. My overall take at the time was that the virus is real, and there are really powerful people taking horrible advantage of the world during a pandemic, but I didn't want to join that

camp. Even the contemplation of their ideas freaked me out. Then I stopped getting the videos for a few months.

But in recent months I began to receive the same types of videos from more than one person over the course of a week and knew that it was the Lord saying 'ok, you now have the bank of knowledge I wanted you to have so that you can understand and accept what you are about to learn'.

It began by learning of the inaccuracies and original purposes of the PCR tests as invented by Kary Mullis and adapted for use to "diagnose covid" by Christian Drosten (interviewed twice on the above mentioned podcast).

I knew all the vocabulary around the PCR due to the podcast so the new information was jaw-dropping. I then realized the numbers of cases and deaths specifically named "covid" made no sense; something was very wrong – something in which many unsuspecting, loving medical professionals had unwittingly played the devil's pawn. And loved ones have been ill without in-person advocates and so many have died alone, but for the loving nurses and doctors who stood with them.

So NOW I'm LISTENING. I heard podcasts and interviews of Catherine Austin Fitts, Prof. Dolores Cahill, Dr. Tom Cowan, Dr. Andy Kaufman, Dr. Sam Bailey, Dr. Sherri Tenpenny, David Icke, Reiner Fuellmich, and others.

These are brilliant and courageous people who put the data together and asked the right questions, and were willing to share their take on the narrative. This was a pivotal time for me.

I'm not sure I would have listened or fully understood in spring 2020, but by December 2020 my paradigm had begun a huge shift.

I began to ask questions and to put pieces of my own health journey together with the current narrative. Due to my own EMF

sensitivity and my study of that field for the past four or more years, I now believe that EMFs and 5G have to at least be weakening our bodies, making them more susceptible to a virus.

I stumbled upon the following information through a series of internet queries with my carrier:

I found out that the small towns near me now had 5G even though we do not yet have it in the country. These are towns of 1,800 and 400 population.

I asked WHEN my local towns got 5G capabilities. The answer was mid November 2020.

Next question was when did my carrier roll out 5G fully. The answer was mid November 2020.

They use a tech called DSS where 5G can ride the waves of 4G towers in parallel so the small frequent towers aren't needed. I think this is a hybrid 4G/5G that will eventually be a full on 5G situation either by the small towers or by the satellites that will be launching (unless the Lord prevents that).

Meanwhile, Beverly Rubik and Robert Brown came out with their preprint indicating "covid" is at the very least exacerbated by EMFs. Confirmation.

Here is the kicker with that – If you scroll down on the statistics page for my state health department's records of all positive "covid" cases you will see that "covid" never really showed up in my state with any significance until mid November 2020 when our entire area of the country blew up with "covid". My guess is that many carriers also rolled out in different locations at the same time.

5G, in our part of the USA, was our "covid" surge! We experienced none of the post-holiday surges that they predicted but for a slight bump after New Years. I had also

just read [The Invisible Rainbow](#) by Firstenberg. His parallels of health issues around the world down through history correlating with cosmic, electrical, radar and EMF roll outs are uncanny. More confirmation.

So, I put together the inaccurate PCR testing with 5G roll out, along with WHO lowering PCR threshold cycle numbers on January 20, 2021, reducing false positives by as much as 85% in some studies. Researchers reviewed test cycle threshold data and it all adds up to a very small pandemic – which is not a pandemic at all.

I saw overall average of all-cause death rates, and the absent flu stats, and I felt like a year of my life – our lives – had been manipulated – stolen – abused.

We'd been betrayed. Those who care for us and serve us in our communities had been betrayed. Much of our local and state leadership had been betrayed. Betrayal became the norm.

My studying has not stopped. More of Bailey and Cowan and Kaufman's views along with finding Dr. Stefan Lanka's work (an ex-virologist in Germany) and my whole view of what really makes us ill shifts yet again (see book called [What Really Makes You Ill?](#) by Dawn Lester and David Parker).

This I am currently sorting out. But I'm far enough along now to have set aside the long year of fear and entered back into the sanctuary with my fellow sisters and brothers for worship.

No discussions yet about why I'm now there – and maskless – but I am there! I'm sure there will be time to share in the days ahead. For now I will joy in the arms of a seven-year-old girl wrapped around my waist after the sermon was over. "I've missed you so much!". And I've missed her too!

For context, our church went back indoors for worship in July 2020 after a season of online only worship followed by outdoor worship. Until the past month or so, my very supportive

husband and I stood outdoors, in the cold of winter, and greeted folks as they entered our church – where masks were always optional – and then worshiped from our van on the radio alone in the parking lot. We then got out to say good-bye to all as they left so that we could remain connected with our church family – a very small rural church. We were sure I needed this kind of protection due to my health issues and this potential illness. It still feels very strange to think that I would have been fine – even at 60, with health issues, I would have been fine. But we just didn't know.

My focus of late has been on the vaccine issue. I'm extremely opposed due to the lack of safety with potential short and long term harm. I'm wondering whether there is even a need for it. And then there is the eerie worldwide push like what is happening in Israel, and how we are hearing of sporting events, and now colleges requiring the shots for entry here in the USA; and the new term coined "medical apartheid" strikes a greater fear than the word pandemic ever did.

More friends and family are getting the shots each week – they are so excited. Even those who weren't going to and felt strongly have caved. They want to fly across the country to see their kids and grandkids and enter nursing homes to see parents, so who can blame them. I pray for their health.



But my aloneness continues and it now faces a brewing anger

among those who believe the resisters or holdouts are a new and a worse danger.

I thank the Lord for the few local holdouts and my internet friends who lend support and join hands. We've even exchanged phone numbers and email addresses so as not to lose one another – our life preservers – across the oceans and the seas of this aloneness – turned connection.

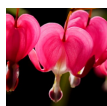

We know the answer of most health care officials and indeed of all pharmaceutical vaccine makers to this question. Vaccine damage is torturous not only to the victim but to their entire family, and the same can be said of vaccine deaths. Censoring of this information by Google, Facebook, YouTube, and Twitter will amount to murder. [The legacy of concentration camp doctors experimenting on prisoners has come home to roost](#), and the mainstream narrative is cheering them on.

Hard to believe that we have come down to this on such a massive international scale. Nazi concentration doctors would be jealous.

The Israeli Ministry of Health and the Pfizer/Moderna coalition keep trying to deceive the public with biased “scientific” articles that hide the most critical data: the death numbers among the vaccinated people from covid and other adverse effects after the first shot.

# Chilling Ingredient Used in the COVID-19 Vaccine

The horseshoe crab is thought to be 300 million years old; that's 200 million years older than dinosaurs. They don't sting, don't bite and don't harm us in any way. The annual spring congregation of egg-laden horseshoe crabs on the east coast provides a vital food source for annual migrations of millions of shorebirds.

But even this harmless sea creature may be annihilated by pharma's insatiable drive to make a universal coronavirus vaccine. In 1990, biologists estimated 1.24 million crabs spawned in Delaware Bay, a main egg-laying nursery grounds and prime collection point for the companies. By 2019, that number had dropped to 335,211. Conservation groups feel that the planned harvest by vaccine manufacturers may lead to the

species' extinction.

Horseshoe crabs are known for their unique blue blood. But it's not the blood's color that is the attraction. A unique chemical found in its blood, called coagulogen, is used by the drug companies to detect as little as a few parts per billion of dangerous endotoxin bacterial contamination in any medication, medical device or vaccine. According to [Associates of Cape Cod, Inc.](#), one of a handful of horseshoe crab blood processors, that's like "finding a grain of sand in an Olympic swimming pool."

First licensed in the 1970's, coagulogen has become the gold standard of pharmaceutical purity testing. This simple test, referred to as a limulus amoebocyte lysate test, or [LAL](#) for short, is named after the white blood cells (amoebocytes) from which the chemical is harvested. The extract is so powerful that if even a trace of endotoxin is present, coagulogen will neutralize it into a gel. If no gel is formed, the product is considered to be free of bacteria. The FDA mandates that all injectable or indwelling materials to be certified as endotoxin-free using the LAL test before a product can be manufactured and sold into the market.

## **Harvesting the Crab: Big Business**

The American LAL industry has been around a long time. The first commercial LAL production facility was established in Chincoteague, VA in 1971. Currently, several production facilities are located from Massachusetts to South Carolina. After the FDA granted approval for the commercial use of the LAL test in 1987, demand for testing reagents soared through the 1990s. Currently, drug companies require at least 80 [million test units](#) each year for drug and device testing. With the specter of using the LAL test to certify more than 15 billion COVID vaccines – two shots for every human on planet – the demand for horseshoe crab blood and LAL testing reagents may soon be stratospheric.

The crabs are harvested by local fisherman and taken to collection facilities which then return them to water within 24 to 72 hours of harvesting their blood. The crabs are returned to the ocean a great distance from where they were initially picked up to avoid recurrent rebleeding from the same crab. The process is rather straight forward: the animals are strapped into collection devices and a catheter is inserted into the sinuses where their blood is removed. Pharma claims it is a harmless procedure, similar to a human giving blood.

But how harmless is exsanguinating 30 percent of the animals' blood?

Nearly 500,000 sea creatures are caught and then bled each year. This number is about to explode. The value of the commercial harvest of horseshoe crabs grew from about \$400,000 in 2004 to more than [\\$1.8 million in 2014](#). In 2018, a teaspoon of LAL was worth about \$75 and the market value had ballooned [to \\$112 million](#).

"The problem is that the companies need a large supply of the blood from live crabs," a [2014 article in The Atlantic noted](#). "Horseshoe crabs live on the seafloor, near the shore. When they want to mate, they swim into very shallow water, and horseshoe crab collectors wade along, snatching the crabs out of their habitat."

## **Synthetic Alternatives**

Because the demand for the LAL agent is about to explode as global vaccine demand is ramped up, alternatives for coagulogen are being explored. It appears a replacement for the blood harvesting may have been found.

Numerous articles have been published about the development of a recombinant Factor C (rFC) test, a recombinant, synthetic alternative to the LAL test. Comparative testing of samples tested with both the LAL and recombinant rFC suggests that the

new test may even be superior for identifying bacterial endotoxins.

The results of a six-year study was published in the journal, *Microorganisms*, in March 2020. The study, which compared endotoxin sensitivity of LAL assay and two different rFC-based assays, demonstrated that both rFC-based assays were comparable to LAL. In fact, the rFC-based methods generated even better endotoxin recovery rates than traditional LAL testing. [The researchers concluded:](#)

“The rFC-based tests were found to represent reliable methods, as equivalent or even superior to LAL assays and suitable for routine bacterial endotoxin testing.”

A similar study, released in July 2020, [concluded:](#)

“rFC assays offer a number of benefits, including compliance with the principles of the 3Rs, i.e., replacement, reduction, and refinement of animal testing by safeguarding animal welfare and promoting more ethical and sustainable use of animals for testing... In summary, we demonstrated that both LAL and rFC assays are adequate for testing and releasing four vaccine products.”

Conservationists fear that the demand for horseshoe crab blood for COVID-19 vaccines may exterminate the crabs and greatly impact the shorebird population that depends on them. A synthetic substitution would be good news for the horseshoe crab population and for the entire environmental and marine ecosystem. And better for humans too.

If it becomes impossible for people to refuse the [hydrogel-contaminated](#) COVID19 vaccine, at least the vaccine will not decimate the horseshoe crab population for its manufacturing process.

## **Event 201**

The film also reveals how SARS-CoV-2 has been turned into a profit center, the possible origins of SARS-CoV-2, and how

Silicon Valley tech giants are controlling the narrative, pushing fearmongering and censoring differing views.

What we're seeing is straight out of the Operation Mockingbird playbook, a clandestine CIA media influencing campaign launched in the 1950s. During the Cold War, the CIA used it to spread propaganda. It recruited journalists to pen fake stories that disparaged communist ideologies.

Today, they're doing the complete opposite, promoting radical socialist ideas that support their plan for a [technocratic economic system](#). ## **CDC Owns Coronavirus Patents**

Willis interviews David E. Martin, Ph.D., a national

intelligence analyst and founder of IQ100 Index, which developed linguistic genomics, a platform capable of determining the intent of communications. According to Martin, in 1999, IBM digitized 1 million U.S. patents, which allowed his company to conduct a review.

Using linguistic genomics technology, Martin made the “horrific assessment” that one-third of all patents filed in the U.S. were functional forgeries, meaning that “while they had linguistic variations, they covered the same subject matter.” In 1999, patents for coronavirus also started to appear, “and thus began the rabbit trail,” Martin says.

In 2003, Asia experienced an outbreak of SARS. Almost immediately, scientists began racing to patent the virus. Ultimately, the U.S. Centers for Disease Control and Prevention nabbed ownership of SARS-CoV (the virus responsible for SARS) isolated from humans.

The CDC actually owns the entire genetic content of that SARS virus. It’s patented under U.S. patent 7776521. They also own patents for detection methods, and for a kit to measure the virus.

U.S. patent 7279327,<sup>5</sup> filed by the University of North Carolina at Chapel Hill, describes methods for producing recombinant coronaviruses. Ralph Baric, Ph.D., a professor of microbiology and immunology who is famous for his chimeric coronavirus research, is listed as one of the three inventors, along with Kristopher Curtis and Boyd Yount.

The law clearly states that genetic segments are “not patent eligible merely because it has been isolated.” So, either SARS-CoV was manmade, which would render the patent legal, or it’s natural, thus rendering the patent on it illegal. However, if the virus was manufactured, then it was created in violation of biological weapons treaties and laws.

According to Martin, Fauci, Baric and the CDC “are at the hub” of the COVID-19 story. “In 2002, coronaviruses were recognized

as an exploitable mechanism for both good and ill,” Martin says, and “Between 2003 and 2017, they [Fauci, Baric and CDC] controlled 100% of the cash flow to build the empire around the industrial complex of coronavirus.”

## **CDC Has Broken the Law, One Way or Another**

Now, here’s the key take-home message Martin delivers. There’s a distinct problem with the CDC’s patent on SARS-CoV isolated from humans, because, by law, naturally occurring DNA segments are prohibited from being patented.

The law clearly states that such segments are “not patent eligible merely because it has been isolated.” So, either SARS-CoV was manmade, which would render the patent legal, or it’s natural, thus rendering the patent on it illegal.

However, if the virus was manufactured, then it was created in violation of biological weapons treaties and laws. This includes the Biological Weapons Anti-Terrorism Act of 1989, passed unanimously by both houses of Congress and signed into law by George Bush Sr., which states:<sup>6</sup>

*“Whoever knowingly develops, produces, stockpiles, transfers, acquires, retains, or possesses any biological agent, toxin, or delivery system for use as a weapon, or knowingly assists a foreign state or any organization to do so, shall be fined under this title or imprisoned for life or any term of years, or both. There is extraterritorial Federal jurisdiction over an offense under this section committed by or against a national of the United States.”*

So, as noted by Martin, regardless of which scenario turns out to be true, the CDC has broken the law one way or another, either by violating biological weapons laws, or by filing an illegal patent. Even more egregious, May 14, 2007, the CDC filed a petition with the patent office to keep their coronavirus patent confidential.

Now, because the CDC owns the patent on SARS-CoV, it has control over who had the ability to make inquiries into the coronavirus, Martin notes. Unless authorized, you cannot look at the virus, you cannot measure it or make tests for it, since they own the entire genome and all the rest.

*“By obtaining the patents that restrained anyone from using it, they had the means, the motive, and most of all, they had the monetary gain from turning coronavirus from a pathogen to a profit,” Martin says.*

## **Dangerous Gain-of-Function Research Was Permitted**

Martin goes on to describe events occurring between 2012 and 2013. At that time, the National Institutes of Health decided to take another look at [gain-of-function research](#), ultimately deciding that gain-of-function research on coronavirus was too risky to continue.

This led to the suspension of funding of such research in 2013. That included funding flowing into Harvard, Emory and University of North Carolina Chapel Hill. However, while the NIH had moral and even legal reasons for suspending such research, they made the funding pause voluntary, not mandatory.

Then, in 2014, when the push-back against gain-of-function research into coronaviruses grew further, the NIH – under the leadership of Fauci – offshored that research to – you guessed it – the Wuhan Institute of Virology in China.

However, as detailed by Martin, the funding was not sent in a straight-forward way. Instead, it was funneled through front organizations such as the EcoHealth Alliance, led by its president, Peter Daszak, whose research, according to the EchoHealth Alliance website, “includes identifying the bat origin of SARS.”<sup>7</sup>

Between 2014 and 2019, EcoHealth Alliance received a long list of grants from the NIH to study “the risk of bat coronavirus emergence.” EcoHealth Alliance then subcontracted that work to the Wuhan Institute of Virology. So, in the end, the U.S. could deny culpability, blaming the outbreak on China when, in fact, it was American research that had been outsourced.

Interestingly, in late-breaking news August 19, 2020, The Wall Street Journal<sup>8</sup> reported that the NIH had notified EcoHealth that it wants “a sample of the new coronavirus that the Wuhan researchers used to determine its genetic sequence,” along with study details and other information.

Additionally, the NIH demanded that EcoHealth “arrange for an inspection of the Wuhan Institute of Virology by an outside team that would examine the facility’s lab and records ‘with specific attention to addressing the question of whether WIV staff had SARS-CoV-2 in their possession prior to December 2019.’”

The problem, Martin notes in “Indoctrination,” is that while the evidence is staring us right in the face, we’re told that so-called “fact-checkers” have a transcendent view of the situation, and they are the ultimate arbiters of truth. As a result, we have this very strange situation where facts and logic are being steamrolled and lambasted as good old-fashioned heresy.

## **Will Truth Prevail?**

The film goes on to interview many other experts, many of whom are convinced the evidence points to SARS-CoV-2 being a manmade virus. Like [Plandemic Part 1](#), Part 2 is well worth your time. As noted by Willis, in today’s fast-paced world, few have the time to do the necessary research to unveil what’s really going on.

The evidence is there, but you have to put it together. This is why documentaries such as “Plandemic” and “Shadowgate” are

so useful. They weave the dots together so that you can see a fuller, more complete picture. Unfortunately, the picture at present is grim.

Yet, we must face it because it's not going away or resolving in the near future. It is important to understand that we are all being subjected to a massive propaganda campaign to move us toward a very specific technocratic agenda. It is only by seeking alternative views that we can begin to understand the truth.

In the case of coronavirus, it should be clear that gain-of-function research is a dangerous game that should not be permitted. By giving researchers the go-ahead to continue this kind of research, even as the NIH publicly "paused" funding for it, the NIH failed to uphold its moral and legal responsibilities.

It's also clear that the CDC has engaged in illegal activities relating to the patenting of the virus, and that they had ample motive and means to profit from a coronavirus pandemic. It's hard to imagine a more corrupt system than what we currently have. The question is: When will something be done about it?

# China Cures Coronavirus with Vitamin C; Research Suggests Selenium

I live in China. This year, like every other, people with severely compromised immune systems were and are suffering from pneumonia. In early January 2020, in [Wuhan, China – a place with dreadful air quality](#)—hospitals started receiving patients.

In fact, for most of November, all of December, and most of January, the air quality index (AQI) was so bad that local governments regularly issued standard health warnings due to high levels of particulate matter. (At my school in Shanghai, if the AQI is over 150, children are cannot play outside. This is based on government advisories.)

And please be aware, far from hiding the problem, government officials in China at the regional and national level, readily provide daily and historical [reports of the air quality index](#), noting particulate matter (PM2.5) and more. Thus we can track data for Wuhan – and most other large cities and urban areas – for the past six years.

Unsurprisingly, those diagnosed with severe forms of COVID-19 are the elderly and the immunocompromised. Additionally, people who have a host of pre-existing conditions are at higher risk. ([NEJM March 30th, 2020](#)). The Boston-based non-profit, Health Effects Institute, says anywhere from [500,000 to 1,250,000 Chinese die due to air pollution](#) alone each year. (see *pages 11-13*). But the question discussed in this report is, “When people have pneumonia or other respiratory difficulties, what are the best treatment protocols?”

### **Ceep it Cimple Ctupid: Intravenous Vitamin C ... Again?**

All across China, not just in Wuhan, but also in other cities that saw pneumonia cases (and note, [Chinese medical teams discuss COVID-19](#) as pneumonia), people are being cured with vitamin C.

I am including the details from a public report written in Chinese and published by a medical team Xibei Hospital, affiliated with [Jiao Tong University](#), in the city of Xi'an, Shaanxi province. (To complete the translation I used a combination of programs and resources: Google Translate, Pleco, and Baidu Fanyi).

*Given what the doctors in Xi'an knew of reports from Wuhan (which is 500 miles away from Xi'an, in the neighboring province of Hubei), and from seeing pneumonia patients in early February 2020, a team at the Xibei Hospital, devised a protocol centered on the use of intravenous (IV) vitamin C against the Coronavirus. They first treated patients on February 10th. Critically ill patients received 200 mg of soluble vitamin C per kg body weight, once every 12 hours. After the first two treatments, the patient would get 100 mg/kg, every 24 hours, for the next four days. (Those presenting with moderate symptoms were given 100 mg/kg on day one).*

Arguably, these doses are too low. Practitioners and researchers like [Dr. Suzanne Humphries](#) (2014) and [Thomas Levy, J.D., Ph.D.](#) (2017), posit that intravenous infusions of vitamin C should be from 50-100g per day, and can be repeated every 3-7 days.

## **The Xibei Protocol**

Using the Xibei protocol, a person weighing 70 kg (154 pounds), would receive a total of 28 grams of vitamin C on the first day. Thereafter, they would receive 7 g per day. The clinical trial in Wuhan gave similar doses. On February 14th, 2020, the [university hospital started giving pneumonia patients a non-body weight-dependent dose of 12 g of vitamin C](#) every 12 hours for seven days.

Even with their relatively low doses, patients in Xi'an were released after four to eight days of vitamin C. Thus, the

protocol, emphasizing the antioxidant, ascorbic acid, has been a clear success.

Nevertheless, my question is, *Why don't we hear of anything about intravenous vitamin C as a routine practice in the United States, or even in other developed countries with reported COVID19 cases like [Italy, Spain, Germany, France, or Iran](#)?*

## **What Does the Research Say about Vitamin C?**

The teams in China did not choose to administer vitamin C due to mere guesswork. To make the decision, they cited the medical literature and used their knowledge about respiratory diseases and oxidative stress.

[Dr. Zhi Yong Peng](#), at the Zhongnan Hospital, at Wuhan University, justified his decision to use vitamin C, noting:

*For most viral infections, there is a lack of effective antiviral drugs ... Vitamin C, ascorbic acid, has antioxidant properties. Clinical studies have shown that vitamin C can effectively prevent [sepsis and related cytokine storms]. In addition, vitamin C can [protect the lungs].*

*Vitamin C can effectively shorten the duration of (or even prevent) the common cold. In a controlled ... trial, 85% of 252 students experienced a reduction in [cold] symptoms, [after receiving] high-dose vitamin C group (1g per hour for 6 hours, followed by 1g every 8 hours).*

## **Xibei Report on Vitamin C**

According to the Xibei Hospital (2020) report:

*For patients with severe neonatal pneumonia and critically ill patients, vitamin C treatments should be initiated as soon as possible after admission. This is because whether the illness was similar to infections seen in the past like Keshan disease, SARS, Middle East respiratory syndrome*

*(MERS), or the current new [COVID19] pneumonia, the main cause of death of patients is cardiopulmonary failure caused by increased acute oxidative stress. When the virus causes increased oxidative stress in the body and increased capillary permeability, early application of large doses of vitamin C can have a strong antioxidant effect, reduce inflammatory responses, and improve [endothelial \(heart tissue\) function](#).*

They add:

*Numerous studies have shown that treatment with doses of vitamin C promote excellent results. Our past experience in successfully rescuing acute Keshan disease and current studies at home and abroad show that high-dose vitamin C can not only improve viral resistance, but more importantly, can prevent and treat acute lung injury and acute respiratory distress (ARDS).*

## **Why not nutrition?**

Dr. Thomas Levy has written many books and has given many lectures on the benefits of vitamin C for curing disease and body detoxification. Of course, Levy attributes this information great pioneer Frederick Klenner, MD. Klenner used ascorbic acid and developed protocols with intravenous and intramuscular applications of high dose vitamin C. [He is published as early as 1949](#)—reporting cures of polio, measles, mumps, chickenpox and more.

Because I knew of the benefits of high dose vitamin C in early February, I encouraged four ex-pat doctors, working in Wenzhou, China, to give it to their patients. Wenzhou, a city of over 10 million, was the second Chinese city placed under a complete quarantine. These doctors ridiculed me and scoffed at the idea that nutrition could provide any relief to coronavirus patients. **One actually said: “A vaccine is the**

**only solution, as a virus has no effective treatment.”** I voiced my objection to that idea, and had plans to use the antiviral drugs – then being touted by the WHO.

Again, I insisted that antioxidants could save the sick. To this, the M.D. added: **“Nutrition is important, but if nutrition is enough, why do governments make hospitals and medical colleges?”**

Why, indeed.

### **What about Selenium?**

When I read the press release and protocol from Jiao Tong University Hospital, I wanted to learn more about Keshan disease. That rabbit hole only introduced me to more evidence that confirmed how nutrition can cure. Below are some excerpts from the [Wikipedia entry on Keshan disease](#):

*Keshan disease, named after Keshan County of Heilongjiang province in Northeast China, is a congestive cardiomyopathy caused by a combination of dietary deficiency of selenium and the presence of a mutated [sic] strain of Cocksackievirus [sic] ... Often fatal, the disease afflicts children and women of child-bearing age. It is characterized by heart failure and pulmonary edema.*

After reading all the references cited by the Wiki page, I concluded the following about Keshan disease and the state of scientific knowledge:

(a) Symptoms of respiratory difficulty and congestive heart disease were found to be prevalent in a wide belt of territory extending from northeast to southwest China (including parts of Shaanxi province. ([See Ge and Yang 1979](#)); those areas which are replete with selenium-deficient soils.

(b) The research holds that *Keshan* disease peaked from 1960–1970, when thousands died of the disease. And during that

decade, China experienced a [man-made famine](#). Then followed by [food shortages, especially in rural parts of China](#).

(c) Intentional dietary supplementation with selenium reduced the incidence and harm of *Keshan* disease in China. ([See Ge and Yang 1979](#)).

## Keshan Disease

[Beck et al. \(2003\)](#) cited a 1979 report from China. The report declared, unequivocally: “Populations living in areas of China with selenium-rich soils did not develop Keshan disease.”

Given their interest, Beck et al. (2003) conducted research into the role of selenium and Keshan disease. They concluded:

*“[Experiments with mice] suggest that together with the deficiency in selenium, an infection with coxsackievirus was required for the development of Keshan disease.”*

Please appreciate the idea that viruses cause disease is not universally accepted—and arguably wrong for Keshan disease in particular. Ge and Yang (1979) claimed that Keshan disease was and is not related to any virus. Instead, they note it as seasonal – coming in the winter. Ge and Yang (1979) explored the question of a viral cause for Keshan disease but rejected that hypothesis due to a lack of evidence. Though most medical practitioners insist that viruses cause disease, recall that in 2005, Peter Doshi discovered that despite [claims that influenza virus kills thousands of Americans every year, for 2001, America had only 18 confirmed flu deaths](#).

The lack of evidence for a viral infection causing Keshan disease and the failure to find a flu virus in fatalities attributed to a virus should guide our thinking about COVID-19 today. Remember, the Chinese doctors in Xi'an treat pneumonia as pneumonia. And they lump together different viruses (SARS, MERS, etc.), saying that each causes oxidative stress.



If disease—all disease—is really about oxidative stress, as Dr. Thomas Levy holds, maybe the type of virus is irrelevant. Keep in mind, even though virologists categorize many types of viruses, there are no true species of viruses ([Racaniello 2019](#), Lecture #1, minutes 56-57).

To determine whether selenium deficiency was a specific link to the coxsackievirus, Beck et al. (2003) injected the influenza virus into selenium-deficient mice and mice fed with adequate amounts of selenium. As we should expect, the selenium-deficient mice had more severe pathology, more inflammatory distress, and produced more T-cells, antibodies, and hormones when they developed the respiratory infection.

Consider that the viruses associated with pneumonia and other types of respiratory distress are different. In human populations, we generally see respiratory ailments with flu-like symptoms, and/or pneumonia, during the winter months. Additionally, we see respiratory illness in persons depleted of an essential antioxidant, selenium. That is, they are suffering from oxidative stress when exposed to the pathogen.

## **Deficiency in Cuba**

Going back to Beck et al. (2003), because their investigation into Keshan disease attributed the ailment to both selenium deficiency and a virus [sic], the team wanted to bolster their thesis with a case study. They provided some discussion about the relationship between said virus and selenium, in another part of the world—Cuba.

During a period of severe nutritional deficit in Cuba (1989-1993), doctors found a rash of patients developing optic and peripheral neuropathy (Beck et al. 2003). The Cuban doctors discovered that their sick patients had oxidative stress due to selenium deficiency, and 84% had some mutated form of coxsackievirus. And the outbreaks occurred in the winter months when vitamin D3 blood-levels would be lowest (Beck et al. 2003).

Just putting these few sources together, we know that:

- people get sick in winter
- a virus is not essential to the formation of an illness or disease.
- More significantly, neither specific viruses nor any distinct diseases have a link to selenium deficiency. Selenium is an antioxidant. And when we raise our antioxidant levels and reduce oxidative stress, we can stay infection-free. Ergo, the key to beating or avoiding pneumonia, a cold, the flu, or any respiratory ailment, is to consume adequate amounts of selenium and vitamin C.
- Other important nutrients to take as supplements are vitamins A, E, and K, B-complex, magnesium, and zinc.

## **Conquer COVID Craziess—and Encourage Others Too**

The last time I took a class at a university was spring 2001. Since that time, I've been enjoying the benefits of my virtual university—the Internet. Over the last 20 years, I have heard lectures from professors and researchers on radio, podcasts, and YouTube. We now have access to millions of peer-reviewed articles, books, and historical accounts. I studied the best that our information age can offer. I learn from Drs. Viera Scheibner, Gary Null, Sherri Tenpenny, Thomas Levy, Rashid Buttar, Sherry Rogers, Nick Gonzales, Leonard Coldwell, Linus Pauling, Fred Klenner, Toni Bark, William Kelley, and many more.

But I have not just absorbed their information, I have used their work as a jumping-off point to do further research ... and you can too.

The allopaths either do not know or do not care about nutrition ([just ask Allan Smith](#)). There is a general awareness of the intellectual laziness of American physicians. I have observed this after interactions with Western-trained doctors from South Africa, India, and the Middle East, the arrogance

of their ignorance is endemic.

From my survey of the current news, if you are in America or Europe, all you hear is that the best doctors can offer is hydroxychloroquine, antivirals or a future vaccine. But from the research, we can see that, instead of their [pharmaceutical drugs \(which can mask symptoms, but does not cure\)](#), what we all need is selenium-rich food (or whole food supplements) and high doses of vitamin C.

### **Can We Get Back To Normalcy?**

There will always be people with viruses and respiratory difficulties. They will be suffering from oxidative stress—and that is NOT contagious. The numbers will rise in the winter when there is less sun. Less sun lowers vitamin D3 levels and reduces the absorption of phosphorous. Additionally, people are more likely to eat more starchy foods and get less vitamin C in their diet.

This is why we hear of [members of Congress](#), professional athletes in NBA, NHL, and world-class soccer players testing positive for COVID. These people were not in China, not eating bat soup, and not sharing ventilators with older people in Italian ICU wards. They did not contract an exogenous virus—their bodies made the virus due to oxidative stress. In fact, spontaneous endogenous generation of viruses, referred to [by some as exosomes](#), would explain why Beck et al. (2003) discovered mutated and more virulent strains of the coxsackievirus in their selenium-depleted mice. They also discovered these strains in human subjects with low selenium. This also notes why researchers are forever finding new and mutated versions of viruses.

Regardless, as Del Bigtree (2020) showed [from the European data](#) (minutes 80-90), in the winter of 2018, death rates across Europe were far higher than today—but there was no declaration of an epidemic or pandemic, and there was no global shut down.

## No Fear of the Unknown

This is not a time to accept economic stagnation and the social dislocation that will accompany it. It is not a time to fear that which you cannot see (a virus)—especially given that no medical doctor has ever proven that said viruses cause illness. (I will present more on the virus theory in future articles).

Get your Vitamin C, selenium, and zinc, wash your hands to prevent bacterial infection and tell your friends to do the same.

# DNA Vaccines and Transhumanism

## DNA vaccines and Transhumanism

[Transhumanism](#) is a futuristic concept where man and technology blend, resulting in soulless intelligent machines. It is a movement that favors the evolution of a new species of human through the use of integrative circuitry. Referred to as “human betterment for the post-human era,” transhumanists assume that humanity will only be enhanced by machines. No damage. No degradation. No possibility for coercion or domination. In a post-human world, humanity as we know it will be obsolete.

In [2012](#), artificial intelligence pioneer Ray Kurzweil became

Director of Engineering and Chief Futurist at Google, hired to work on projects to teach machines to learn. Kurzweil predicts that by 2030 ([\*there's that date again\*](#)) technological advances will allow tiny nano-bots to be injected into the bloodstream, pass through the blood-brain barrier and integrate into the brain. The human brains can then be connected to "the cloud," achieving a level of brilliance never thought possible. So, essentially, biological beings will become "non-biological entities." In his book, *The Singularity is Near: When Humans Transcend Biology*, Kurzweil states, "In the future, there will be no distinction between human and machine, or between physical and virtual reality."

But if our brains can tap UP into the cloud, it only makes sense the what's in the cloud could be pushed DOWN into our brain...So, the question becomes: *Who* controls the specific information we're allowed to tap into? *Who* determines what is downloaded into us? The disturbing vision of thousands – or millions – of [\*Manchurian Candidates\*](#) comes to mind.

## **The Quest for Control of the Human Brain**

In former-president [\*Obama's 2013\*](#) State of the Union Address, he announced his plan to invest in brain mapping technologies. In April of that year, a \$100+ million initiative was launched called [\*BRAIN\*](#), which stands for Brain Research through Advancing Innovative Neurotechnologies. Multiple public-private partnerships were funded, including the [\*Allen Institute for Brain Science\*](#), the [\*Howard Hughes Medical Institute\*](#), [\*Salk Institute for Biological Studies\*](#), and the Kavli Foundation and Institutes. Our tax dollars also funded this project; the government allocations included:

- \$20 million to the National Science Foundation to study how Big Data could be used to understand the ability of the brain to generate thoughts, emotions, and memories;
- \$40 million to the National Institutes of Health (NIH) to develop training tools and resources to support the

BRAIN initiative; and

- \$50 million was given to the Defense Advanced Research Projects Agency (DARPA) to develop tools to capture and process dynamic neural and synaptic activities.

Using those funds – and more – DARPA announced in 2016 it would develop the Neural Engineering System Design ([NESD](#)) [program](#). Touted as the next-level brain-computer interface (BCI), the NESD system is designed to turn brain activity into a binary code, allowing humans to engage with machines wirelessly, by simply thinking.

While many amazing medical uses could come from this research, from treating PTSD and traumatic brain injuries (TBIs), to maneuvering brain-activated exoskeletons and prosthetic limbs, it takes very little imagination to see how this research could quickly turn dark.

- What if the post-human world was dominated by strong, mechanical humanoids with enhancements designed to benefit institutions, at the expense of the individual?
- Will the drivers to create bionic humans be economic efficiency, cultural modification, and military dominance?

Post-humans will live longer and be Global Citizens, a future where humankind is melded into a single, apolitical identity ruled by the UN and governed by the global Sustainability Agenda. Bionic humans will have no need to connect, even with creatures of their kind. Advances in animal cloning and embryonic stem cell technologies are bringing human cloning closer to reality, eliminating the need to procreate – satisfying the globalist's concerns regarding planetary [overpopulation](#). Need more worker bees? Create them at the factory – they need no benefits, no vacations and can work 24/7.

## DNA Vaccines: Permanent manipulation of humans and animals

DNA vaccines, a type of genetic engineering, were first tinkered with in the early 1990s. A small snip of DNA, say, from a herpes virus, is inserted into a bacterial “bubble” called a plasmid. When the plasmid-laden vaccine is injected, the cellular immune system gears up to eliminate the foreign protein (plasmid + viral DNA snip) and at the same time, the humoral immune system creates antibodies against the viral DNA. When a herpes virus enters the body, the memory T-cells and B-cells work together to attack the foreign virus, eliminating it and avoiding the infection.

This process is not without [problems](#).

- The DNA snip can be incorporated into the host’s DNA, leading to chromosome instability. The mutagenic affect can *turn on* oncogenes and *turn off* tumor suppressor genes, **leading to cancer**.
- Genetic expression is the process where genes create proteins. Genetic *over-expression* is when the process “goes rogue” and produces massive amounts of foreign protein, **destroying human tissues** via both acute and chronic inflammation.
- Often the plasmid used is **resistant to antibiotics**; the same antibiotic resistance can be transferred to the [host](#).
- The plasmid DNA can appear very similar to the vaccine recipient’s DNA. The anti-DNA antibodies can attack human organs with similar DNA sequences. The result is **autoimmunity**, clearly identified as the cause of nearly [100 different](#) diseases and suspected to be the cause at least 40 more chronic and potentially life-threatening conditions.

A concern that sounds like science fiction is the use of DNA vaccines in food-producing animals. The foreign DNA can be

incorporated into an animal's DNA, getting into the human food supply. The plasmid DNA can disrupt the animal's microflora, and even potentially transform the environmental microflora as the animals defecate.

This level of genetic manipulation makes DNA vaccines a dreamy tool of the transhumanists. With a host of companies working on biotic human body parts and DARPA working to build killer robots, designing DNA vaccines to *enhance human DNA* is only a step away. In fact, [Editas Medicine](#), a US-based company, announced in November 2015 that the trials with the first humans to have their DNA genetically modified were well underway.

If robots could think, feel and have a conscience, would that make them human? Or, would the lack of genetic material always render it as non-human? Using the combination of artificial intelligence, [nanotechnology](#) and DNA vaccines to insert human genes and human characteristics into machines is no longer just for the movies. At what point are humans no longer humans?

As vaccine recommendations become mandates – and [30 states](#) are now pushing for mandatory vaccines, will you retain your right to refuse?

# Vaccine Contaminants, Nanotechnology, and Cancer

Over the last 17 years, I've read hundreds of medical journal articles on the problems associated with vaccines. I have written and spoken about vaccine contaminants – stray viruses, aluminum, mercury, polysorbate 80, animal cells, and so on. I have often wondered *"What else is coming through that needle?"*

This article, ***"New Quality-Control Investigations on Vaccines: Micro and Nano-contamination"*** published on January 23, 2017, in the peer-reviewed journal, the [International Journal of Vaccines & Vaccination](#) absolutely blew me away.

Here is a snapshot from this [must-read, full-text article](#):

***A team of scientists in Italy decided to examine batches of vaccines, looking for contaminants not listed as ingredients. 44 types of vaccines manufactured in Italy and France were analyzed using an Environmental Electron Scanning Microscope. This method was chosen because the matter can be separated into either organic debris (called aggregates) or inorganic debris (called clusters). The identified particles were counted three times by three different operators, with***

an error rate of less than 10%. **They found inorganic contaminants in every single one.**

**The presence of micro- and nanosized particulate matter, composed of inorganic chemicals, metals and combination elements whose presence is inexplicable.**

The particles are foreign bodies, and can produce a **chronic inflammatory reaction because the particles cannot be degraded.** The tiny nanoparticles can **enter the cell nuclei and interact with cellular DNA.**

The inorganic particles are **neither biocompatible nor biodegradable, that means they are biopersistent.** They can induce immediate effects **or the effects may be delayed for a long time** after administration.

Identifying Aluminum and NaCl is obvious because they are commonly used in vaccines and they are declared components, but the **other materials are not supposed to be in vaccines or in any other injectable drug.**

In most circumstances, **the combinations detected are very odd. They have no technical use, cannot be found in any material handbook** and look like form randomly, for example, when waste is burnt. In any case, **whatever their origin, they should not be present in any injectable, let alone in vaccines given to infants.**

Wow.

While the entire article was disturbing, I found this little paragraph to be the most eye-popping of all:

- **Feligen**, the only veterinary vaccine tested, proved to be **the only sample free from inorganic contamination**, while Allergoid generates a **layer of inorganic salts [aluminum] so thick** that it does not allow to detect other particulate contaminants.

Why would a shot used for allergies (Allergoid) be *loaded* with aluminum, which is [known to cause allergies](#)?

Why would a cat vaccine have *no contaminants*, while vaccines destined for humans are *loaded* with toxic particulate matter?

If these vaccine contaminants are due to sloppy manufacturing, the animal vaccine should be contaminated with the same elements, which includes titanium, tungsten, **stainless steel**, chromium, nickel, aluminum, iron and a very long list of combination formulated compounds such as SiAlSBaFe (silicon + aluminum + sulfur + barium + iron), a particle found in the European flu shot, Agrippal, and AlSiMgTiMnCrFe (aluminum + silicon +magnesium + titanium + manganese + chromium + iron) a particle found in **Repevax**, one of many European DTaP vaccines.

On a side note, [Repevax](#) is one nasty vaccine. In addition to the large particle named above, the vaccine contains diphtheria and tetanus toxoid, 4-in-1 pertussis antigens, and three polio viruses. The vaccine is produced in VERO cells from African monkeys. It has residual formaldehyde, glutaraldehyde, streptomycin, neomycin, polymyxin B and bovine serum, all used during the manufacturing process. For good measure, 1.5mg of aluminum phosphate is used as an adjuvant and polysorbate 80 and phenoxyethanol are present as excipients. It is approved for use in children 3yrs of age and over, adolescents and adults. Would you want this injected into *your body*, or the body of your child?

## What about these metals?

According the article, [“Toxicity and Carcinogenicity of Essential and Non-Essential Metals,”](#) the metal particulates identified in these vaccines could be causing serious harm. Here are three:

- **Nickel:**

- In vitro cell transformation studies have provided fairly conclusive evidence that nickel can be carcinogenic in humans and animals. (p. 34)
- a potent inducer of DNA lesions, sites of damage in the base-pairing or structure of DNA. (p. 35)

- **Chromium**

- the carcinogenic and mutagenic effects of chromium are without question (p. 15)

## ▪ Lead

- Children can develop CNS problems when exposed to inorganic lead
- Lead does not penetrate the CNS of adults as readily as it does children, but the peripheral nervous system of adults is affected by lead, leading to peripheral motor neuropathies (p. 16)

I have long believed that the chemicals or viruses – *or something else* – in vaccines contributed to the spectrum of brain injuries seen in both children and adults. The frontal lobe of the brain, the area behind the forehead, is where [empathy](#) is expressed. If this area is damaged, a personality disorder can emerge where a person can no longer appreciate or comprehend the emotions of another. Without compassion, they can intentionally harm others without regret.

Are we seeing this today in our society, in many of our young people? Vaccination at birth with the hepatitis B vaccine began in 1991...26 years ago. The ramp up of the vaccine schedule started then and today, children are [subjected to](#) 50 doses of 14 vaccines before age 6, and 69 doses of 16 vaccines by age 18. Across the US, the number of college students taking antidepressants skyrocketed between the 1990s and 2005. Estimates vary, but it has been estimated that up to 50% of all students seen at student health centers are given a [prescription](#). The violence on college campuses has grown exponentially. One in 5 women and one in 16 men are sexually assaulted on a campus. Rape is the most under-reported crime; 63% of sexual assaults are not reported to [police](#).

## Infanrix Hexa – 65 Toxins Found. All Risk. No Benefit.
