# North Dakota House Passes Bill Prohibiting Government Mask Mandates

North Dakota House Passes Bill Prohibiting Government

The North Dakota House of Representatives has passed a bill that would ban the implementation of President Joe Biden's proposed national mask mandate. The bill would "prohibit state and local officials, schools and businesses from mandating face masks."

The anti-mask mandate bill passed on Monday by a narrow margin of 50-44, and is slated to head to the state Senate, according to the *Grand Forks Herald*.

Three months ago, Republican North Dakota Gov. Doug Burgum imposed a state-wide mask mandate, which expired in January. Several cities across the state, including Bismarck, Fargo, and Grand Forks had already required the use of masks in public spaces.

The sponsor of the anti-mask mandate bill, Republican state Rep. Jeff Hoverson, argued that North Dakota should be as free as its southern neighbor, South Dakota. The *Grand Forks Herald\_reported* that both state's coronavirus numbers have steadily decreased, despite North Dakota's imposition of a

mask mandate. In contrast, South Dakota under Gov. Kristi Noem never imposed a mask mandate and allowed residents to make their own decisions.

Hoverson described the mask mandates as "diabolical silliness," and described them as a part of a larger conspiracy by "unelected, wealthy bureaucrats who are robbing our freedoms and perpetuating lies."

Supporters of the bill claim that masking does not prevent the spread of COVID-19, with many pointing out the ineffectiveness of cloth masks and paper masks as ineffectual forms of security theater. As many experts have pointed out, masks require an N-95 rating to be truly effective against the spread of infectious diseases, which many people are not wearing despite "masking up."

Republican state Rep. Jason Dockter also spoke out against Burgum's legislation, arguing that states should allow counties, schools, employers, and cities to have "local control" over the decision.

Experts argue that while COVID-19 cases dropped after the North Dakota governor issued a mask mandate, it was likely due to many other factors, including social distancing efforts and restrictions on the operation of businesses, more so than the mask requirement, the <u>Herald reports</u>.

The North Dakota bill comes following the release of new CDC guidelines pushing the importance of mask-wearing, including an advisory to wear two masks. According to the CDC, the organization ran experiments in order to examine the ways in which to improve "the fit of medical procedure masks: fitting a cloth mask over a medical procedure mask, and knotting the ear loops of a medical procedure mask and then tucking in and flattening the extra material close to the face. Each modification substantially improved source control and reduced wearer exposure."

Dr. Anthony Fauci, the top U.S. official on COVID, has been criticized for saying that wearing masks will be required indefinitely.

# Man Flying Back Into Canada Refuses Airport COVID Test

Man Flying Back Into Canada Refuses Airport COVID Test

Canadians who test positive forced to undergo quarantine in government facility.

After a new policy mandating Canadians take an airport COVID test to determine whether they will have to undergo quarantine at a government facility was introduced yesterday, a viral video clip shows a man refusing to take the test before being issued with a fine.

Prime Minister Justin Trudeau outlined the details of the new policy in a tweet yesterday afternoon.

"Update: If you're flying back into Canada, you'll need to show a negative PCR test result before you board the plane — and as of today, you'll need to take another PCR test when you land. You'll then have to wait at an approved hotel, at your own expense, for your test results," Trudeau tweeted.

Under the rule, if the test is negative, Canadians are still forced to quarantine in their own homes, a policy that will be "enforced" according to Trudeau.

Those who test positive for COVID-19 are forced to quarantine in "designated government facilities" for 14 days. Another PCR test is then required towards the end of the quarantine.

However, a video clip posted to Instagram by Chris Sky shows him arriving at an airport in Canada and refusing to take the test. The video has received over 500,000 views.

"Got my bags, we're gonna go outside and refuse their stupid test and tell everybody to refuse their stupid test," says Sky in the clip.

The video shows Sky being asked why he is not wearing a mask before he explains to officials that the COVID test is a "violation of our charter rights section 6 and a violation of the Emergency Act  $14.1 - so\ I'm$  going to be declining your test today."

Sky then tells the other people in the queue to deny the test if they are Canadian citizens, claiming "they cannot stop you, they cannot force you, you are a citizen, you have rights."

Police then ask Sky for identification before asking again if he is refusing to take the test.

"I refuse to take your test a million percent," he responds.

After being told he is getting a ticket, police refuse to say how many people have been "convicted," with Sky insisting the number is "zero."

"Why? It's a violation of our charter rights, so when that ticket goes to court, they throw it the fuck out — it's that simple," states Sky.

After being issued with the fine, Sky was presumably allowed to leave the airport and re-enter Canada without undergoing a COVID test or being told to quarantine.

# My Reply to the One-Sided BBC Panorama Programme on Vaccination

(This is the script of Vernon Coleman's contribution to the film `We will not be silenced' (Ask the Experts II) which was published on 20th February 2021 by Oracle Films and Covileaks. It is Vernon's response to a Panorama programme which was broadcast on 15th February 2021.)

My name is Vernon Coleman. I was a British GP for ten years and resigned because I refused to break patient confidentiality by putting diagnoses on sick notes. That, incidentally, was the only time I was ever disciplined. I was fined by the NHS for this and it's something I am proud of because patient confidentiality is important to me.

The BBC's official policy is not to allow any discussion or debate about vaccination. Instead, they accept as gospel anything the Government, the regulators and the drug companies tell them. Those who question any aspect of the Government line are banned.

This is an extraordinary state of affairs for a national broadcaster which is supposed to inform and educate its viewers and listeners and to provide a fair and accurate account of the news; and it means that those who obtain all or most of their information from the BBC are never fully informed about a topic which is, almost certainly, the most important health issue of our times.

To use a sporting metaphor it's as though the BBC were to report on a football match between Manchester United and

Liverpool but to tell its viewers and listeners only what the Liverpool players were doing and to count only the goals scored by Liverpool.

The result, of course, is propaganda. And the BBC's policy exposes it to ridicule and contempt from independent scientists and journalists.

It is impossible to defend such a one-sided approach to informing the public.

Especially at a time when the public is desperate for accurate information.

Despite all the Government's propaganda and advertising, around one third of the population still have serious doubts about the planned vaccination programme and there are millions who are desperately seeking solid, unbiased information upon which to base their decisions.

They won't get that information from the BBC which steadfastly denies the evidence and follows the official 'Gatesian' line that the covid-19 jabs are effective and safe when the science clearly shows that they are neither.

Indeed, instead of just refusing to debate with those who question the plan to give an experimental covid-19 jab to everyone in the world, the BBC seems to do everything it can to demonise those who dare to tell the truth about the jab and, indeed, about everything else related to covid-19.

When it comes to propaganda, the BBC has form, of course.

But it's in the area of covid-19 that the BBC's ignorance and failure to understand research or science really becomes blatant and embarrassing. Their attempts to fact check expert claims are so poor that I fear that an infant school teacher would be embarrassed if her pupils produced such shoddy work as part of a science project. This is truly pathetic, a mark

of D minus would be for getting the date right.

For example, when the BBC decided that the Government's official line on mask wearing needed support, they ignored around 100 solid, scientific papers, interviewed a solitary advisor who said masks were essential and safe, quoted a curious WHO report that masks wouldn't lead to hypoxia and then concluded that a whole library of scientific evidence could safely be ignored or, in their words, debunked.

If this embarrassingly childish approach to science was simply embarrassing to the BBC it wouldn't matter much. I don't think the BBC has much of a reputation anyway these days.

But there are, sadly, some who still believe what they hear or see or read from the BBC. And the lives of those people are in danger as a result of this grotesque parody of journalism.

By the time the covid-19 fraud has been finally condemned, I believe the BBC will have been responsible for tens of thousands of deaths.

What a long way the BBC has travelled from the stout and solid aims of Lord Reith that the organisation should educate and inform.

Like many others I've spent most of the last year campaigning against this fraud because I know that governments around the world are engaged in a massive conspiracy. And, for the record, my campaigning has cost me hugely in terms of reputation and finance. BBC staff are well rewarded to endorse the Government's Gatesian line. I haven't made one penny out of my videos or articles about this fraud. On the contrary the cost in personal and financial terms has been massive. I made a video for Brand New Tube explaining exactly how my Wikipedia page had been deliberately altered to demonise me within days of my starting this campaign in March

Anyone who says the covid-19 jab is extremely safe and completely effective is lying. There is a long list on my website of just some of those who've been killed or injured by what is without question an experimental jab.

Anyone who looks at my record will see that I have spent my life campaigning passionately on behalf of patients. I am not going to be bullied into silence by people who don't understand the meaning of science or the responsibility of journalists.

As always, everything I've said or written is based on hundreds of scientific papers and real evidence — much of which is available on my website, free. My two recent books on the fraud are also available free on my website.

And, unlike the BBC, I don't have any financial links with the Bill and Melinda Gates Foundation.

Smeeth is a member of the steering group for UK Biobank, the UK's major medical database, which has catalogued, in depth, genetic and health information from over half a million UK participants to date. Last year, UK Biobank partnered DNAnexus, a cloud-based analytics platform aimed at genomics and other clinical big data. DNAnexus is funded, in large part, by donations from Google and Microsoft, with Gates himself listed here as an owner.

Why didn't Panorama — which the BBC describes as an

investigative documentary series, revealing the truth about the stories that matter — consider these huge vested interests when choosing Smeeth alone to "debunk" professional opinions of dozens of specialists from around the world?

Medical freedom advocates around the globe know <u>Edwin Tamasese's</u> name. <u>In June 2019, I visited Samoa</u> at the invitation of Prime Minister Tuilaepa Lupesoliai Neioti Aiono Sailele Malielegaoi who has served as the <u>Prime Minister of Samoa</u> and Leader of the Human Rights Protection Party since 1998.

I went to Samoa to attend <u>an independence celebration</u> and discuss with the government the introduction of a medical informatics system that would allow Samoa's health officials to assess, in real time, the efficacy and safety of every medical intervention or drug on overall health.

Edwin Tamasese had arranged the trip and <u>Children's Health</u>
<u>Defense</u> had offered to finance the innovative system. <u>Samoa</u>
<u>banned</u> certain vaccinations after several children had <u>died</u>
<u>following MMR vaccines</u> the previous year.

A nephew of the Prime minister was diagnosed with autism following a vaccine-induced fever and seizures and government officials, including the Prime Minister were curious to measure health outcomes following the "natural experiment" created by the national respite from vaccines.

Samoa's choice had infuriated the Global Medical Cartel. A <u>mild measles outbreak</u> in November gave that cohort the opportunity to turn Tamasese into an international villain. Near the end of the month, following the introduction of

an Indian-manufactured MMR vaccine, many Samoans began dying.

On the ground, Samoan families blamed the vaccine and poor hospital protocols — mainly the use of panadol and widespread vaccination of measles-infected hospital patients — for the mortalities. The global cartel and the Pharma-compliant press blamed anti-vaxxers and Tamasese.

When police arrested Tamasese, our movement created an international furor.

In December 2020, the government <u>dropped all charges</u> against Edwin.

#### Here is Edwin's extraordinary story:

On the mention of a measles outbreak in Samoa, I thought nothing of it. I had fairly good insight into measles as an infection and having had it myself, was not concerned and expected it to be a non event. We had also had several small outbreaks since 2003 according to WHO statistics that had come and gone without event despite our <a href="low vaccination rate of around 31%">low vaccination rate of around 31%</a> for the last 14 years.

I was shocked therefore when the first death was announced and started to pay more attention to what was happening. I also noted comments on social media from contacts of mine talking about the struggle they were having dealing with patients at the national hospital.

The first case I was to come across was a staff member who came to me with her nine-month-old baby. She had taken her baby to the hospital twice, but said the baby was getting worse. She had the child with her. There were lesions across the baby's body with a red rash. I asked her what the hospital had prescribed for her child. She showed me a white bottle filled with a pink liquid labeled "Pamol," a liquid form of paracetamol or acetaminophen and a liquid antibiotic mixture labeled as augmentin.

With my basic knowledge of viruses having been a livestock farmer for two decades, I knew the medications she was using were not going to work. I had vitamins in my house at the time that I gave to her. Vitamin C and A. I also told her how to use them.

By the next morning her child had made a significant turn around and was visibly stronger. Using social media she posted her thanks for the assistance. In addition she requested I assist a neighbor. I told her I am not a doctor and they needed to be going to the hospital for assistance. She said the neighbor had been to hospital twice as well and they were progressively getting worse. I agreed and went to see them as they were close by.

When I entered the home I was horrified at what I saw: a 9-month-old boy, his 2-year-old brother and their father were all lying together in one room of the house. The 9-year-old was severely ill, with cracked lips and eyes swollen shut, oozing pus. I asked why the child was not admitted to hospital. They confirmed that they had been there twice, but the child was not admitted. I was shocked. The child clearly looked like he was going to die.

I asked to see the medications that they had been given. It was the same pamol liquid and antibiotics. I asked if they had been taking them as per prescription and they said yes. I then reiterated that the child should be in hospital, but the mother was clearly concerned. She said the children are dying at the hospital and the medications they were given were not working. I said ok, I am not a doctor, but if you agree, I will help you. She said yes and I gave them the vitamins and the doses to give.

By the next morning the 2-year-old and father were up and about, feeling much better. The very ill 9-month-old was breathing easier and the swelling of his eyes and cracks on the lips were much improved. He fully recovered over the

next few days much to my relief as I honestly thought he was going to die.

This is when things got out of control. Word spread very rapidly. I started to get calls from everywhere for help. I had also realized at this point that the medications being given out by the hospital were ineffective and needed to change urgently before more lives were lost.

I tried to call the measles helpline to get through to them, but the phones just rang out repeatedly. I also started to email several of my contacts in the medical community to hopefully urgently get changes put through. In addition, I contacted a few of my contacts who are members of Parliament to see if they could help.

In addition, organizations like Children's Health Defense had reached out from the U.S. Quite quickly when I raised my concerns with them I was linked into a group of medical professionals by Mr. Kennedy and we worked on a protocol to ensure effective treatment. In addition, a nurses' group from Australia made contact.

I also decided to make public posts on Facebook passing on information on how to treat measles using vitamin C and A. I also passed on information on using <u>Carica Papaya leaf Extract (CPLE)</u> for those who did <u>not have access to these vitamins</u> as they are ordinarily beyond the affordability price point of many.

Amongst all this activity, I had put out a request on Facebook to overseas families to send vitamins A and C. The first to respond with a shipment was Tays Way in Australia with hundreds of packages to follow from all over the world. The way the world responded was overwhelming and very touching. My parents, brother and I hired an extra vehicle and we formed two teams that went out to distribute vitamins. We also had a local team of supporters who were

helping to pack vitamins and distribute as well.

In the midst of this activity, we were being harassed by a local group and online trolls who felt we were undermining the government efforts to contain the outbreak, not realizing that there was a major issue with the treatment protocol, confirmed by the U.S. team of doctors.

As we were going out to villages treating children, a very troubling trend was emerging. Over 90% of those we were treating were either recently vaccinated or according to the parents, had caught "measles" from a recently vaccinated person. This led to a call to a few contacts in the medical community to ask if it was possible that the vaccine could actually be the source of the outbreak.

A contact who happens to be on the medical board of New Zealand mentioned that there are a few ways that this could happen. Either the vaccine is under attenuated or not weak enough, the population being injected is vulnerable and too weak to take the vaccine, the vaccine is not being transported in a suitable chilled environment allowing it to regain virulence or the vaccine itself is contaminated and we are not dealing with measles at all, but another pathogen.

This became a major source of concern as our small team was overwhelmed, not to mention the <u>National Health Services</u> (who merged with the <u>Ministry of Health in 2017)</u> and the World Health Organization (WHO) were increasing vaccination campaigns.

As activities ramped up and news spread that we were having very good success treating children, I received my first call to come in to the police station to meet with the police. During this conversation, the officer interviewing me explained that he had been directed by NEOC (National Emergency Operations Center) to arrest me for disobeying

the state of emergency orders. He stated that he had been told that I had posted a video on facebook telling parents not to come into the national hospitals for treatment.

I advised him that this was not the case at all and convinced him to review the video on his computer. He agreed and we watched it together. In the video I am clearly directing parents to take their children into the national health services and to ensure that they are given vitamin A as per the WHO guidelines for their treatment.

A few days after this interview, I received an email response from one of the doctors who was supporting our efforts in the U.S., Dr. Jim Meehan, who wrote a full protocol based on the treatments that we were giving and endorsed it from his medical opinion. I printed this out and presented it to the secretary for the Prime Minister in the hope that he would be able to support it and prevent further unnecessary deaths. I am not sure if he received it, however.

Early the next morning, I was to go to another of the islands to work on the coconut oil factory that I am a shareholder in. The night previous, I had received a call from one of the district hospitals. A parent of a very sick little girl was calling asking for help. I had spent an exhausting day delivering vitamins to several villages and almost did not take the call.

By this time I had lists of messages asking for help, my phone was sending constant message alerts to such a degree that it was almost as if it was ringing. It was at the stage where I would just say a prayer, flip through the messages and whichever one it stopped on I would choose to help. I just imagined if this person was me appealing for help with a sick child and I decided to take it and go. I got there in the late evening and the mother met me in the carpark. I said that I did not think I was allowed into

hospitals, but she said do not worry, just come in. I went through the usual spiel: "I am not a doctor, the protocol I am giving you however has been endorsed by doctors. If you agree that you understand this then I will help you." She agreed and I helped her out. While I was speaking to her, I could hear several other parents looking after children saying my name. "That is Tamasese" from Facebook. They came over and asked for help as well. I explained again that I am not a doctor, but if they wanted my help still I would help them. They agreed.

Early the next morning, I headed to catch the ferry to the other island to get to the oil factory. I called to follow up with the sick child I had visited the night before at the district hospital. The mother stated that her child had regained her strength overnight and the nurses said she could be discharged. The other patients that I helped also experienced the same outcome and were all waiting to be discharged except for a 3-week-old baby who was going to be discharged the next day.

Unfortunately in my happiness with the outcome, I made a post on Facebook stating that an "angel" visited Poutasi district hospital and the measles ward was going to be cleared. This post immediately set off events within the NHS who directed the district hospital to hold all the patients and contacted the police.

As I was on the way to Savaii, I took another one of the messages. Just by chance it happened to be on the island I was heading to. It was a message from Australia asking if I could help. I responded yes and we began to communicate. She mentioned the child, a little girl, was in hospital in Tuasivi, Savaii, the island I was going to. I explained everything about what we were doing and the protocol and said I did not want to go into the hospital, but could meet the parents outside. She thanked me and organized the meeting.

It was while waiting to meet these parents outside the hospital that an individual I know saw me and pulled up his car to talk to me. He mentioned that I am entitled to my view, but that I was being disruptive of government efforts. I stated that I would be as disruptive of the deaths of children as I could possibly be and if NEOC thought this was contrary to what we should be trying to achieve then that was their problem. He left and I continued to my meeting with the parents. I explained how to use the vitamins and left it with them.

Later that evening just on dusk, a police car turned up at our factory. I was on a call with some other parents asking for help. I told the parents I would call them back and approached the car. The officers advised that they had been informed to deliver a letter to me to inform me that there was going to be a two-day lockdown starting in the morning. If I was seen outside my place of residence during the period of the lockdown, I would be arrested on site. I asked why I was getting this special letter and nobody that I was aware of in the country was getting one. They said they were just acting on the orders of their superiors. I agreed and signed the letter and they left.

Around 9:00 p.m. that evening, the parents of the child I had just provided vitamins sent me a video of the child I had just helped six hours previous. The change was miraculous. The little girl had been lying on her back with a distended stomach and an IV in her arm before she started on the vitamins. Three doses later of a gram a dose every two hours of vitamin C powder mixed in 20 mls of water and she was sitting up eating. She was very close in age to my daughter and seeing her recover like that brought me to tears of happiness and frustration at the same time.

The fact that there was an effective treatment at hand and children were still dying needlessly was incredibly disheartening.

The following morning I noted a post from a friend who was to help with the mass vaccination efforts of the government. Considering the pattern of infection that made it look like the outbreak was coming from the vaccine, I made a post in reply that I later took down.

Two hours after this post, the police arrived and said that I was going to be arrested, with the charges to be advised later. The oddest part of this arrest was that one of the officers had been hugging me across the shoulders and thanking me for helping his relative the day before.

I was then transported to the police post at Tuasivi near the main town center where I was held for one night. My greatest concern was for the parents of the child I had spoken to the previous evening that I was intending to meet when the curfew was to be lifted in the afternoon.

In the meantime, I had no method to contact the team working the main island where the outbreak was at its worst. We had set up a distribution pattern where we would create delivery routes and assign people to areas to drop off vitamins. We were also keeping records of infections, age, sex, village, vaccination status and then following up on outcomes. It was an incredible effort from a very small but dedicated team.

I was held for two nights in this cell. Sleeping on a dirty concrete floor in a filthy cell with rats and cockroaches running about and an unflushed blocked toilet in one corner. Early the second morning, I was taken by ferry to the main island to be questioned at the main police headquarters.

When I arrived I asked what my charge was. They said they were yet to finalize it. I said you can't hold me for more than 24 hours unless you charge me. They asked me to wait and I complied. There was no point escalating the

situation.

I was finally given a charge of incitement against a government order under state of emergency powers in the afternoon. The registrar at the advice of the police asked that I be confined until bail hearing. The registrar complied and I was then transferred to the main prison to be held. I ended up spending three nights in that prison which was thankfully in much better condition then the one I had left behind.

At the bail hearing on the third day, the Judge agreed to release me on bail under the specific conditions that I release my passport and not say anything against the specific measles vaccine on social media. He disagreed that I should not be allowed to give out vitamins as requested by the prosecution and permitted me to continue doing this.

After being released on bail the outbreak had subsided significantly. A group of us met to look at what data we had available to try to determine what had actually happened in Samoa to cause this outbreak to be so severe and why the death rate was an astronomical one in 68 and not one in 5000 as would be expected if you trust the official statistics.

It was then that a few anomalies showed themselves. At the commencement of the outbreak, 36 tests were sent to Australia. Only seven came back positive for measles. What then were the other 29? All those for which samples had been sent were "suspected measles" cases.

The record of what this infection was if not measles needs to be made public. In addition, the Government stated that the mass vaccination campaign eliminated the virus and was a resounding success.

The infection charts, however, do not support this at all. In fact the mass vaccination drive statistically had no

significance at all. Infection rates had been falling from a peak on the 26th of November. Mass vaccination occurred on the 5th and 6th of December. The vaccine takes two weeks to develop antibodies. Over the two weeks, the infection rate continued to plummet. By the time the vaccine would have become effective on the 19th-20th December, the infection rate was already as low as the seven case high that had led to the declaration of the outbreak.




Figure 1. Epicurve Measles in Samoa by date of onset, date of report: 29 December 2019 (N=5,675). Source: Health Emergency Operations Centre (HEOC) Situation Report, Ministry of Health Samoa; Incident Name: Measles outbreak - October 2019; Sitrep No. 44.

Not only that, cases continued to occur on the six days after which the vaccine should have eliminated all cases.

In my view, and unless the government releases the results of all tests, both positive and negative, and what the infection actually was and if vaccine measles or some other pathogen was part of this outbreak, the suspicion that there was a faulty batch of vaccine, in particular the vaccine that was the basis of the vaccination drive from Serum Institute of India is credible.

What also showed through very clearly is that there are very simple and effective treatments available that should have been used in the outbreak.

"One of the problems that we have in the United States that you don't have in Europe is that in 1997 we changed the law in our country to allow pharmaceutical companies to do direct consumer advertising on television.

So, today the big television networks can make up to 70% of their revenues on pharmaceutical products. What it means is that pharmaceutical companies are dictating the content of what we see on the news...

Anderson Cooper gets 12 million dollars a year and about 10 million of that comes from pharmaceutical companies...

Rupert Murdock, who runs Fox News also runs/owns the biggest vaccine company in Australia.

And so you have the press in our country that has absolutely been taken over by the pharmaceutical industry."

#### Dr. Reiner Fuellmich:

"This problem seems so big, and the resulting damage seems so horrendous all over the world, that many of us have been

thinking that maybe the national courts will not be able to cope with this. So the idea has been floating — and we've been discussing this with a number of our colleagues from all over the world — that maybe we're going to need — once we get this to stop — we're going to need, in order to go and deliver justice, we're going to need something like a Nuremberg trial, second generation. Is that something that lawyers you work with have also been thinking about?"

**RFK, Jr.** explains the obstacles that have been created globally that would make it difficult to be treated fairly and the challenges we face. He focuses on getting the public involved and focusing on the parts of the national and local court systems that still have integrity.

"We need to try to figure out ways, first of all, of communicating to the public.

So, we're off of social media. The mainstream press is now captured by the pharmaceutical industry. But there are now other, evolving, ways for people who are learning to communicate to each in other ways.

We need to establish credible ways for people who care about democracy, who care about civil rights, who are concerned about the ascendency of the medical cartel to begin really revolting against the increase and unacceptable power of those power centers.

And one of those ways in through communication.

The other is, in many of our independent nations, there are opportunities in the courts — where you still have integrity in the courts and judicial system of some of our countries. And it's getting smaller and smaller, more constricted.

But, to me those present the best opportunity. Public organizing, public communication and the use of the courts."

#### Dr. Reiner Fuellmich:

"And I think what also makes sense — what we've been doing for months now...

I think it also makes a lot sense for all of us to continue to cooperate and share the evidence that we have, so that we're all on the same page and that we're all on the same level... Because the problem is universal. It's almost identical worldwide...

I think it's really important to show that, as you said, those parts of the judicial system that still have integrity are still functioning — and that we — you and I and the rest of the people who are working with us — are doing the best we can to show and to get as many decisions as possible from the courts of law that say:

**PCR tests cannot tell you anything about infections.** And that **there are no asymptomatic infections**. And even if there were that doesn't play a role. As many of these decisions as possible.

Because the PCR test. the Drosten PCR test, was and still is the centerpiece of this whole thing.

If we destroy that narrative, I think this house of cards is going to come down crashing soon."

The New York State Education Department <u>issued a letter</u> Feb. 16 informing all public schools in the state that parental consent to <u>COVID-19</u> tests for their children is not required for in-person instruction, or for participation in any school activities, including extracurricular activities.

The letter, which applies only to public and charter schools, follows in the wake of a <u>lawsuit</u> challenging the closing of New York City Schools and the <u>mandatory testing</u> for students.

The lawsuit was filed Dec.16, 2020, by eight New York City

parents and <u>Children's Health Defense</u> (CHD) against the New York City Department of Education and Mayor Bill de Blasio. The parents are represented by Attorneys James Mermigis, Ray L. Flores II, Robert F. Kennedy, Jr., CHD chairman and chief legal counsel, and Mary Holland, CHD president and general counsel.

The <u>Feb. 16 letter</u> from Kathleen R. Cataldo, assistant commissioner, Office of Student Support Services said:

"The Department has received reports from the field that some school districts are requiring parents' consent on behalf of their children, to COVID-19 testing as a condition of activities including in-person learning and extracurricular activities. The Department hereby clarifies that parent/guardian consent for COVID 19 resting of students may not be a condition of in-person learning or other school activities." (Underlining from the original.)

Since Nov. 19, 2020, children in grades 6-12 have been completely excluded from all in-school education. NYC has provided no specific date by which these students will be back in school.

Since early December, K-5 and special needs students have been able to attend "blended learning," usually just 1-2 days per week, but only if they submit to in-school polymerase chain reaction (PCR) genetic testing for COVID-19. If parents refused, the education department relegated their kids to remote learning for at least the next 10 months.

NYC schools were open to all students for blended learning September through mid-November, even though all families had the option of remote learning. Mayor de Blasio shut schools down again because of a rise in the city-wide PCR positivity rate.

As plaintiffs' experts declared in their <u>lawsuit</u>, PCR testing does not diagnose COVID infection, even though NYC has

represented to parents that it does. PCR testing generates many false positive results, leading to disruptive and expensive isolation and quarantine, the plaintiffs allege.

The U.S. Centers for Disease Control and Prevention states that in-school testing without voluntary consent is "unethical and illegal." Coercing parents to sign consent forms on threat of exclusion is not voluntary, the plaintiffs allege, and the education department is acting in flagrant disregard of federal public health guidance.

As the lawsuit outlined, remote learning disproportionately harms those who can't afford access to modern technology, including high-speed internet, computers, tablets, printers, scanners and more. Further, most students in NYC are Black and Hispanic, and many parents are wary to submit their kids to medical procedures without their oversight. They wonder what really happens with their children's test results and DNA samples

The <u>United Federations of Teachers</u> (UFT), the <u>New York City Teachers Union</u> issued a statement that the state's letter contradicts a plan agreed to by the schools and the union. "We will fight to make sure these protocols stay in place" according to a statement on the <u>UFT Facebook page</u>.

<u>NY Teachers for Choice</u> responded to UFT with an <u>open letter</u> to UFT President Michael Mulgrew outlining why NY Teachers for Choice supports the new guidance. The letter ended with:

"Virtually every other school district in New York, and across the country, does not force COVID testing on staff or students because doing so is illegal. I understand and respect that you are trying to do what you believe is best and safest for your membership. However, the UFT should not stand on the side of forcing an illegal practice to take place under its watch. Please accept the new guidance from NYSED and expand upon it to ensure teachers and staff rights are respected as well."

The lawsuit by CHD and New York parents will continue until the school closure issue is resolved.

# Paris Is Turning Its Dark Underground Parking Lots into Mushrooms Farms

<u>Paris Is Turning Its Dark Underground Parking Lots into</u> Mushrooms Farms

Unused underground parking garages in the French capital and beyond are being turned into bespoke mushroom farms, thanks to a company called Cycloponics.

Allowing an extremely nutritious crop to be grown and sold directly in Paris, the initiative is part of a number of renovation projects the City is encouraging and sponsoring.

Along with shitake, oyster, and white button mushrooms, <u>Cycloponics</u> grows chicory—a French delicacy that can grow in the dark—as well as microgreens like mini broccoli. These are delivered via bicycle to local organic grocery stores.

Their location in Paris is called "The Cave," and it's one of three such converted garages that have been co-founded since 2017 by the coincidentally named Theo Champagnat. "70% of people live in towns today, and in this population there is a demand for local and organic products like ours," says Champagnat.

In a <u>BBC video news report</u> on the operation, Dougal Shaw details how during the 1960s and '70s, large apartment blocks were almost always built with underground parking garages. Now car ownership is dwindling, and many of the garages are becoming derelict haunts for illicit activity.



in the mid-2010s, Parisian Mayor Anne Hidalgo launched *Reinventing Paris—The Subterranean Secrets of Paris* which offered designers, architects, and others a chance to help transform abandoned underground lots into cultural spaces, gastronomic eateries, and other civic-minded projects.

One such project turned an old metro stop into a market/food

court on one side of the platform, and the other into a cocktail bar, featuring luminous light and trendy designs.

But this offering in Paris wasn't the first time Cycloponics took to the dark and dank in the heart of a French city. Their first project, built in an old German bunker dating back to 1878, is located in the city of Strasbourg, while their most recent mushroom project is centered in Bordeaux.

These days? Champagnat and the 10 people who work with him <u>are able to harvest</u> around 100-200 kilos of mushrooms from their lots per week. Not bad for a bunch of college-age basement dwellers.

Excerpts from Unofficial Transcript, prepared by Truth Comes to Light:

#### Catherine Austin Fitts:

The reality is, if you have a group of children who are that poisoned — I'll just say poisoned — whether it's the food …or the injections. If you have a group of people that is that poisoned and their IQs are falling that significantly, that's the end of your future.

...If you look at all of the predatory behavior — whether it's financial, whether it's physical — you know we have several generations of young people who are literally being destroyed. And it's, to me it's the most immoral and unethical thing about our culture right now. And it's absolutely the end of America as we know it if it

...If you look at what we're doing to our... living being, it's far more destructive than the financial fraud. But there's a deep connection because one of the ways that the establishment gets people to go along with destroying the next generation is they offer them opportunities to make money destroying the next generation.

...When I first got to Tennessee, I was talking with one of my neighbors who had just retired from teaching and I said 'why did you retire?'. And she said 'I couldn't stand being lobbied by the parents to put the kids on drugs'. And I said 'what do you mean?'. And she said 'well, you know there're incentives in the school system — the more kids we get on drugs. But the parents would lobby me to certify that the child was ADHD so that they could get social security disability'. And I said 'and what was the goal of getting social security disability?'. And they said they needed the money to feed the child. So the only way they could get the money they needed to feed and care for the child was to drug the child...

The school systems have been weaponized to get these kids on drugs. And the financial incentives for both the schools and the teachers and the parents is all engineered...

This is very thought out. This is a very sophisticated design. And it's frightening because you're watching kids being drugged who they don't need drugs. Now, if you look at the amount of bad food and TV and, I would argue, 'entrainment subliminal programming' being engineered into these kids, it's amazing they can stand up or think.

...The riots were designed, financed and engineered.

...I say it sends the same message as all the pharmaceutical executives: It's okay to make money destroying other people's lives, other people's businesses and other people's bodies. In other words, we are bringing up generations of children who are being taught that it is okay to make money doing things that kill other people and destroy other people.

You know, we have a society that has basically become financially dependent on destroying each other. It's a liquidation model.

...I was assistant secretary [HUD] and there is a lot of use of mortgages and mortgage insurance to wander drug money. And so the intersection between mortgage fraud and narcotics trafficking is very intimate, and serious and long-lived. So I got into looking at narcotics — another way of making money destroying our children.

...It can't be solved in Washington. All Washington can do is suck up to the people who control the 500 billion to a trillion and print money. And what we've come down to in this country is a huge war between the people who... are independent producers (and can earn money) and the people who print money.

I don't know if you've seen what's going on in the administration, but they are moving people into place who are all money printers. They're taking over the treasury function. So you're watching the central bankers, you know, not only engineer a reset and a takedown of the economy, but a takeover of the fiscal and treasury function. And once the central bankers control all of that, then there is no republic...

The system that runs this planet is highly centralized. And it's highly designed and planned... I call the committee that

runs the world Mr. Global — that's my nickname for that group — and they are very much in control…

I think it's one of the things many people struggle with is understanding how tightly it is managed. And yet they're going to now see a whole new layer of management...

As the new technology is rolled out... you've had one group who's behind a wall of secrecy and they've been advancing and applying very sophisticated technology. And the other group has literally not noticed. And so you have the two groups that have come... they've literally become as if different species to each other.

...There is no doubt we've now introduced a whole variety of new technologies. And the situation is completely out of control...

If you look at who's implementing the liquidation of our society, it's us. We're doing this. Every one of us.

...Sometimes people say it's so overwhelming, I don't want to hear it, it's too depressing. The reason you want to walk through the door of an honest map is that's where you find your power...

There are solutions. But we have to implement the solutions instead of our own demise.

...At the oligarch level we're [US and China] Siamese twins.







#### Dr. Mikael Nordfors

We are lots of experts here in our organization — lots of professors, nobel prize winners, doctors — and we agree on very strongly on some points like the PCR test is not reliable and the lockdown measures has no scientific background. Actually, they are proven to not work in the multiple studies published now. And still we do it. And these experts, when WHO they are paid to say a certain agenda and they don't dare to have a debate with us. They only use censorship to silence us down. And that shows that we are right and they are wrong, because if they were right and we were wrong they could easily challenge us in a debate. And then people could decide for themselves. But we're not even allowed to have the right to have a debate today.

#### Monique Janssen

And you know how the brain works, pictures go straight into our unconscious brain. We are being brainwashed wherever we go. This is not humanity. We should stop this immediately. This is child abuse. And they really believe that they have to do this in order to keep us safe because they are so loyal to us (our children). They want to keep us safe. And it's not their job. So we have to show them what it is to be courageous, so they can mirror that. We have to show them to be loving people, to help each other, to hold hands, to make jokes, to love, to make serotonin, to make endorphins, to make dopamines, to make oxytocin. We have to show them. They learn from us how it is to be humans.

#### Agathe Levi Palsvig

They take us by our empathy and morals and say things like 'keep each other safe' and 'follow the rules'. And, of course, an empathic person would fall for that. While these rules are getting more and more preposterous for a virus with a survival rate of 99%. We are not stupid!

Human beings are hardwired for connection and we have a fundamental need to belong. We are here to love, to connect, to learn and to be in service — something that is being made almost impossible for all of us to fulfill right now. So I just want to remind everybody that we're not up against people who are asleep. Okay? We're up against those people who would pay any price to keep the good people, our people, asleep. We are the minority until we become the majority. We are here to win.

#### Mads Palsvig

We have started the 4th of November. We copied the success from Iceland in 2008. So we are doing a lot of pots and pans noise. And we call it the clinky clunky. And the atmosphere is really something everybody should try. Because I thought we do the pots and pans to wake up the politicians, to make a statement that they don't pay attention to the people, they don't listen. I thought it would just be a lot of noise. But actually you get into a rhythm. And it's actually very very pleasurable actually.

#### Maneka Helleberg

There is not like one scientific truth. Science is turning into religion right now. Science is not a religion. It's not supposed to be. Science should be a discussion, an open debate. In a democracy there is a

debate. Period. If we don't have an open debate, it's not a democracy. And that's what we need to reclaim again, over and over.

#### Mads Palsvig

I'm a former investment banker and it was a total shock to me when I realized that the stories we hear about money creation was not true. But it is the privately owned banks that are creating money. And then I stumbled upon Executive Order 11110 by your uncle, John F. Kennedy, who produced money the way it should be, by the government, for the people, debt-free money.

We have now started political party where we want to issue money the same way. And also I've been looking on Occupy Wall Street and the Yellow Vest Movement in France, and I strongly believe that one of the reasons it's not working is because there's no political platform. So we are now working within the World Freedom Alliance to support and encourage political movement — so that all the movements come together.

But actually also have a plan for how we can get rid of the politicians who are starting wars left right and center, poisoning our food, our air, our water, our medicine and certainly also our vaccines.

#### Robert F. Kennedy, Jr.

I'm very, very heartened by what I see happening in Denmark — the commitment to human rights, civil rights, to democracy. To resistance to this medical cartel, to the imposition of totalitarian controls and the creation

of the surveillance state.

You were talking about my uncle, John Kennedy... He said the primary job of every American president is to keep the country out of war. He had been in a war himself and he saw, not only the brutality of war, but he also saw what war and global war and a waging of war does to civil society and to democracies.

#### Mick Stott

I'm a grandfather. I'm a father. But I'm also an exsoldier and I served for 30 years. I'm here to speak to the veterans and the military people whom I've grown to love, know and help. And what I would say is that we are in danger as a police force and a group of soldiers of becoming agents. We're becoming order followers.

And I can say this to you from the heart, the most dangerous group of people that exist today are the ones that follow orders without questioning those orders. As veterans we've been lied to for years. We know what that feels like. Veterans are the intermediary group of people that stand between the politicians and the people we signed up to protect and serve. As did police officers.

So what I would say to veterans, serving soldiers and the police people out there is: Remember why you signed your oath. Remember why you took that oath. And why you took the shilling. And you decided to fight abroad for these people. It's us that are going to step in into that gap that exists — to make sure that we fulfill our promise to our communities. And to keep those communities what they're meant to be, which is a community.

And I'm going to say to veterans out there, and you will

totally understand this, but a civilian group might not understand this, I'm saying to you guys: Get ready to stand too.

#### **Mathias Levi Palsvig**

A lot of people are following orders and are wearing masks out of empathy. And they have good intentions. And they are doing it because they think that wearing a mask will help save grandma's life. But I can tell you my grandma has been isolated for months. I call her every day and I think it is absolutely devastating that she has to be isolated.

And if I was an old man who grew up during fascism and war, I think I would take the chance and see my grandchildren. And take the chance, maybe die happy, rather than live as an isolated slave. I think that there are a lot of people here who are more qualified than I am to tell you about the virus or about law. We have here world famous immunologists, virologists, doctors, researchers. And for that reason, I would like to talk about something else.

My great-grandfather was in a concentration camp. My mother is from Moscow and, in World War II, 30 million Russians died for our freedom. And that's only one country, from one war. Now if you look over time, all the wars, there have been in all countries, how many millions of people or probably billions of people have died for our fundamental freedom and for our rights? And I'll be honest. It is — it's absolutely heartbreaking to see so many people I know, so many people I love, who are willing to give away their freedom because the government tells them to do it, because of a virus.

Well, I have one thing to say: If they want to take away my rights and my freedom, they can come and take it from me — over my dead body!

#### Dr. Johan Denis

Trying to keep the light out on a sunny day, in a dark room, is very difficult. You really have to cover everything up, and be vigilant, because the smallest and the slightest crack will let the light in and reveal brightly what is inside. Truth is this shining light.

Therefore, every voice that speaks the truth becomes a beam of light that make all dark coverings crumble.

#### Dr. Andrew Kaufman

We've been patient. We've been tolerant. We've even been, at least some of us to some degree, compliant. But this has got to end now. You've been on the streets telling your government this and it has worked so far. Now is the time to keep going. You have the momentum. You have the numbers. You have the heart. I'm grateful you're standing up.

Your government has tried to oppress you with the proposed epidemic law. They want you to take the vaccine.

If you refuse, they want to prohibit you from shopping, working and traveling. If that fails, they want to put you into concentration — I mean quarantine camps. If that fails, they'll have the police force you into the camps. And if that fails, they want to have the police force you down and give you the vaccine. But you won't let that happen.

You told them and they backed down. But you have to keep telling them because they will keep trying. As many of you know, it turns out this whole pandemic of COVID-19 is a fabricated web of deception. It is a tool of manipulation and control.

Picture for a moment that there were no news reports, no masks, no social distancing, lockdowns or store closings. Would we see that anything was different from all the past years of our collective experience? Have we seen people dying in the streets? Have we all lost people unexpectedly who are in good health? Are we burying bodies in our backyards? Or is there only the illusion of a pandemic?

At present, these tyrannical policies are based only upon so-called cases. This is not the same as when a doctor diagnoses you with an illness. To be a case, you can be completely healthy no symptoms at all. All that is required for a case is to have a positive test. You don't need a test to tell you when someone has a fatal disease. The reason they're using this test is to manipulate us. Let me tell you about this so-called PCR test. It stands for Polymerase Chain Reaction. This test, as discussed many times by its inventor Kary Mullis, is not suited to diagnose an illness or prove the cause of a disease.

"If they could find this virus in you at all. And with PCR, if you do it well, you can find almost

anything in anybody. It starts making you believe in the sort of Buddhist notion that everything is contained in everything else. Right? I mean because if you can amplify one single molecule up to something that you can really measure, which PCR can do, then there's just very few molecules that you don't have at least one single one of them in your body. Okay? So that could be thought of as a misuse of it. Just to claim that it's meaningful."

It is a research and manufacturing tool. Yes—manufacturing DNA or RNA sequences. In this situation, it's manufacturing a fake disease. So what this test actually does is make a lot of something out of a little of that something. That's it. It takes a short sequence of DNA or RNA and replicates it over and over. It's like looking for a needle in a haystack by making that one needle magically turn into 100 million needles. Certainly you would be able to see that many. One problem is, however, that when you amplify those needles, you also amplify twigs , spider webs, lint, pebbles, dust, ants, hair and anything else that's close to size of the needle.

So when you see the thing in large quantities are you seeing the needles or are you seeing pebbles and twigs? According to Dr. Fauci in the United States, if you amplify more than 35 cycle thresholds then all your results are twigs and pebbles.

"If you get a cycle threshold of 35 or more that the chances of it being replication competent are minuscule. You almost never can culture virus from a 37 threshold cycle. So I think if somebody does come in with 37, 38 even 36 you got to say, you know, it's just it's just dead nucleotides. Period."

But that is exactly what they're doing in many countries — like in England where they're using a whopping 45 cycles. All their results are junk.

But there's more. The particular RNA sequences this test looks at are based upon a theoretical model of a theoretical virus' genes. It uses short sequences called primers to find the target of a so-called virus. A group of researchers in Spain recently searched these primers in a special database open to the public called BLAST and found that they are identical, not only to several different human sequences, but also to as many as 100 different bacteria. That means that almost anything like a fruit, a puddle of water, a sheep, or another animal, could test positive. And, in fact, they all have.

Since bacteria are ubiquitous, virtually anything could be positive for this PCR test. But based on this fraudulent and worthless test, your rights have been compromised. The more testing that is done, the worse it has gotten and will get.

You must resist and say no to the swab. Do not get tested or allow your children or family to get tested. They control the game through testing. If they set the cycles high, the number of positives will be high. Then they will order more lockdowns and other tyrannical policies.

One of those policies is about wearing masks. In my opinion, masks are one of the most heinous parts of this crisis. They make us alienated and estranged from our brothers and sisters. They tell us to hide our identity in shame. They tell us to be afraid of our neighbors. They tell us to shut our mouths. They tell us not to smile. It's time to throw away those masks forever.

Thanks to Danish scientists, Dr. Bundgaard et al., we now have for the first time high quality randomized

controlled trial data on masks for COVID-19. After being refused by three major journals, this paper was finally published earlier this week. I must note that the authors had to write up their discussion with some ridiculous statements just to make it look more favorable to the mainstream to get published. But their scientific conclusions were very clear. There was no evidence that masks reduce infection. I repeat, no evidence. Thank you, Denmark, for this major contribution.

#### Dr. Mikael Nordfors

There might be some kind of new virus out there. And there is some new disease that I didn't see so much before, so many patients. But on the other hand, it's not hard to heal it. I for me, I know how to heal COVID-19. And you're not allowed to talk about this. Because you can do vitamin C, vitamin D, zinc, malaria medicines like hydroxychloroquine, and also awesome treatment vitamin C infusions, and the corticosteroid inhalation. And if you combine all these things and some anticoagulants very few people have to die from this disease. And if they are so bad that they die, they will probably die anyway in a couple of months. It's undeniable now.

I mean you can see it so clearly how this totally well-known medicine hydroxychloroquine suddenly it becomes the devil and you cannot take it. I say, they will never find any vaccine that is even close to vitamin D. So you just take vitamin D and the COVID problem is solved. That's why we don't have any COVID in the summer because you get sun. That's proven in many, many studies. There is a linear relationship between vitamin D level and COVID-19 mortality.

#### Dr. Margareta Griesz-Brisson

I would like to appeal to the physicians and to our leading medical groups, please show some character and some backbone. The pandemic is a medical issue and it has to be solved medically. Please stop the madness and behave professionally.

#### Robert F. Kennedy, Jr.

If you say to yourself, who are the people who are censoring our debate? All of those people are the people who are making money on the lockdown. Facebook. You know they have permanently bankrupted half the businesses in America [voice from audience: "and in Europe"].

And the people who are decimated and destroyed is the middle class.

#### Catherine Austin Fitts

What they are doing is moving to destroy as much independent income as possible. Because independent income is what has been supporting the democratic process. And if they can force everybody onto their centralized, or centrally-controlled, transaction systems, then they can proceed to have complete control. So they don't want independent producers, they don't want independent income. They want a centralized control.

So, since March 2019, global billionaires are up 27% net worth and hundreds of thousands of small businesses and farms have been put out of business. And that's not an accident. That's intentional. What you're trying to do is shift all the income into your platforms, starve your enemy, and basically put them in a position where they're dependent.

I think one of the things that has made it difficult for all of us to push back on this is they're working on multiple tracks. The central bankers are working on one track. The pharmaceutical companies are working another track. The military is working another track. The tech guys are working in another track. The telecommunications people are working in another track. And if you're not integrating across all those silos, you don't see how the vision is going to come together in the future.

You know, so this is a battle about everything, if you will. But it comes down to two visions. One is a vision of humans who are sovereign under what I would describe as divine intelligence or authority. And the other is humans are a resource, like a barrel of oil. So it's transhumanism technocracy against freedom and belief that we are capable of civilization.

#### Heiko Schoning

We are free people. We do have the choice to choose the freedom or to choose a tyranny. And, I kid you not. Nobody should say that he was not informed because it's all written in a book. They call it "COVID-19 The Great Reset". Do we want this? We are the Great Resist!

#### Dr. Scott Jensen

Edmund Burke said something like this: "All it takes for evil to prevail is for good people to do nothing."

I'm so glad that you're not doing nothing. You're addressing a contrarian narrative. You're questioning the conventional narrative. You're seeing data corrupted and saying 'why?'. On any issue that you have, there's experts diametrically opposed to each other. You can't say trust the experts. ... So, let's have some democracy. Let's have an open debate. Anything they tell us to do is illegitimate if it is not the product of open debate and democratic process. Let's debate it and let's find out the truth.

As the article notes, there are bills working their way through the legislatures of North and South Dakota that would in effect be a form of state nullification:

Recently, Rep. Tom Kading and eight other Republicans in the North Dakota House <u>introduced</u> HB 1164, which would task the attorney general with reviewing the constitutionality of the

president's executive orders. If any of his orders are deemed to be unlawful, this bill would prohibit any state or county agency or publicly funded organization from enforcing the edict.

The list of issues covered under the bill are:

- 1. Pandemics or other health emergencies.
- 2. The regulation of natural resources, including coal and oil.
- 3. The regulation of the agriculture industry.
- 4. The use of land.
- 5. The regulation of the financial sector as it relates to environmental, social, or governance standards.
- 6. The regulation of the constitutional right to keep and bear arms.

Thus, an easy first candidate for such legislation is Biden's recent mask mandate, which unconstitutionally prohibits humans breathing without cloths on their mouths and noses inside any public transportation, including in-state rideshares and taxis. The CDC created an entire criminal offense for something that never passed Congress.

There is a similar bill in South Dakota (and what piqued my interest here was that it is being offered by the representative for Harrisburg, a small town not far from my home town of Sioux Falls):

South Dakota already has a <u>similar bill</u> to HB 1164 targeting Biden's executive lawmaking. Rep. Aaron Aylward of Harrisburg, South Dakota, introduced <u>HB 1194</u>, which would set up an executive board to review the constitutionality of executive orders pertaining to the six issues laid out in the North Dakota legislation.

What seems to be clear with various state resolutions and

bills in the past few years, is that they are beginning to push back. We've seen Missouri pass state bills denying any state law enforcement being used to enforce any federal gun grab, South Carolina considering a bill to recognize any bullion coin as legal tender, Texas — well, where do we begin? — considering all sorts of measures and doing all sorts of things, like creating its own state bullion depository, attempting to woo NASDAQ's data center to Dallas, and even considering a referendum on secession. There are secession movements in California, Oregon, and Washington states, and on and on we could go. Iowa recently passed a bill funding *students* directly, and bypassing schools.

Where all this will end neither I nor anyone else knows. I do think that the trend will continue, and grow more acute; it is a measure of how deeply the distrust in federal institutions goes, and it is a measure of just how deeply divided the country is. That divide, let me reiterate, is cultural, not just political.

That said, there's something suggested by this article that invites a little speculation, namely, that the two bills in the respective Dakotas appear to be *coordinated*, and that means there been a bit of talk back and forth between Bismarck and Pierre (the state capitals of North and South Dakota, respectively). Perhaps there have even been meetings over lunch or breakfast between respective legislators in the two states.

If my guess about coordination is correct, then it won't be long until one sees other American midwestern, plains, and southern states coordinating too.

Or to put it country simple, the fallout continues...

This time it's from a small country in the north east on the Baltic Sea that has long lived under the influence of Germany, Russia, Belarus and Poland. As in many other countries, citizens of Latvia have warned against a political disease. In December, their freedom movement organized the biggest rally after the war to protest against the Covid measures calling on the support of other nations. Leaders of the movement are condemning the lockdown policies taken on the basis of meaningless PCR-tests. In his recent public declaration Mr. Janis Plavins, one of the leading voices of the Latvian freedom movement supported his claims by quoting the decisions issued by the supreme courts in Austria, Portugal and Bosnia who all concluded that lockdown measures violate their constitution.

Citizens deplore the refusal of government officials and experts to take part in any debate on the issue in spite of repeated demands supported by several peaceful rallies and car caravans. According to Mr. Plavins, "In Latvia whistleblowers and freedom supporters are being prosecuted in unlawful and harsh ways with extremely high fines, defamation, attacks on their personal businesses and the closing of their bank accounts". A famous activist and a nurse were even arrested and jailed after a single interview where they expressed their views on the government's measures.

Latvians know the taste of totalitarian regimes and the feeling of anger against their government is rising.

# German Court Declares Regional Lockdown Unconstitutional in 'Politically Explosive' Decision

German Court Declares Regional Lockdown Unconstitutional in 'Politically Explosive' Decision

A German district court has declared a strict lockdown imposed by the government of the central state of Thuringia last spring unconstitutional, as it acquitted a person accused of violating it.

A trivial case about a man violating strict German lockdown rules by celebrating a birthday with his friends has ended up in a decision the German media described as "politically explosive." A district court in the city of Weimar did not just acquit the defendant but also stated that the authorities themselves breached Germany's basic law.

Thuringia's spring lockdown was a "catastrophically wrong political decision with dramatic consequences for almost all areas of people's lives," the court said, justifying its decision. It particularly condemned a restriction limiting private gatherings to the members of one household and one person outside of it.

It was this regulation that a local man violated by hosting a party attended by his seven friends. Yet, the judge said that the regional government itself violated the "inviolably guaranteed human dignity" secured by Article 1 of the German basic law in the first place by imposing such restrictions.

According to the court, the government lacked sufficient legal grounds to impose the restrictions since there was no "epidemic situation of national importance" at that time and the health system was at no risk of collapsing as the Robert Koch Institute reported that the Covid-19 reproduction number had fallen below 1. The judge also ruled that the regional government had no right to introduce such farreaching measures at all since it was up to lawmakers to do so.

The lockdown imposed in Thuringia represented "the most comprehensive and far-reaching restrictions on fundamental rights in the history of the Federal Republic," the court said while calling the measures an attack on the "foundations of our society" that was "disproportionate."

The decision, however, only has an effect on this specific case, which saw the defendant acquitted and freed from the need to pay a fine of €200 (\$243). When it comes to any broader considerations the ruling is not legally binding, although each German court can pass a judgment on the

constitutionality of orders issued by any authority other than the Bundestag or a Landtag (a regional parliament).

Still, the decision has sparked quite a stir among some officials and local media outlets as Germany currently has a pretty similar strict lockdown in place which was imposed by the federal government in November and repeatedly extended and tightened ever since.

This week, Chancellor Angela Merkel's cabinet extended the restriction until mid-February.

Thuringia's regional public prosecutor's office already filed a complaint against the court ruling issued on Wednesday demanding it be reviewed and possibly overturned with the case handed over to another judge. The decision needs to be "reviewed to further develop the law and ensure unified jurisdiction" when it comes to lockdown and its violation, a spokesman of the prosecutor's office, Hannes Gruenseisen, told the local media.

Lockdown has been a contentious topic in Germany as the nation repeatedly saw protests against the measure in various cities throughout autumn and winter 2020. At some point, the protesters even compared their struggle to the anti-Nazi resistance, sparking a scathing rebuke from the German Foreign Minister Heiko Maas.



In honor of MLK day on the 18th of January, we repost this article that first appeared on GR in April 2018.



Martin Luther King Jr. 4 April 1967 Speech at Riverside Church, Upper Manhattan, New York. The speech was delivered on the same day (April 4, 1967) one year before MLK was killed on April 4, 1968.

We should carefully reflect on MLK's message to the World.

MLK understood the relationship between America's war agenda and social justice and civil rights in America. "No one who has any concern for the integrity and life of America today can ignore the present war. [Vietnam]".

One cannot be a civil rights leader without taking a stance against U.S. led wars.

In the words of Martin Luther King: "Silence is Betrayal".

Today with war hawks in the White House and the U.S. State

department, America is leading a military adventure which in the real sense of the word threatens the future of humanity.

But this is not a talking point on network TV. Nor is it a concern of the "antiwar" movement. Meanwhile, the media is "killing the truth" either through distortion or omission.

Today we commemorate the passing of **Martin Luther King** who was assassinated in a high level conspiracy on the orders of key agencies of the US government (see text of Judgment).

Very few Americans are aware of the historical 1999 civil law suit of the King Family against the US Government. (Shelby County Court), Tennessee.

"After four weeks of testimony and over 70 witnesses in a civil trial in Memphis, Tennessee, twelve jurors reached a unanimous verdict on December 8, 1999 after about an hour of deliberations that **Dr. Martin Luther King, Jr. was assassinated as a result of a conspiracy.** In a press statement held the following day in Atlanta, Mrs. Coretta Scott King welcomed the verdict, saying, "There is abundant evidence of a major high level conspiracy in the assassination of my husband, Martin Luther King, Jr. And the civil court's unanimous verdict has validated our belief."

"Making Money on War" is what motivated the killing of Martin Luther King on April 4, 1968. In the words of William Pepper (King Family Press Conference):

Because he took on those forces, powerful economic forces that dominated politics in this land, they killed him. He was killed because he could not be stopped. He was killed because they feared that half a million people would rise in revolution in the capitol of this country, and do what Mr. Jefferson said needed to be done every 20 years, to cleanse this land. This land has not been cleansed. This nation has not faced the problems that Martin Luther King, Jr. died trying to face and confront. They still exist today, the

forces of evil, the powerful economic forces that dominate the government of this land and make money on war and deprive the poor of what is their right, their birthright. They still abound and they rule.

#### Decision of the Jury

"Do you also find that others, including governmental agencies, were parties to this conspiracy as alleged by the defendant? Your answer to that one is also yes."

Mr. Chairman, ladies and gentlemen,

I need not pause to say how very delighted I am to be here tonight, and how very delighted I am to see you expressing your concern about the issues that will be discussed tonight by turning out in such large numbers. I also want to say that I consider it a great honor to share this program with Dr. Bennett, Dr. Commager, and Rabbi Heschel, some of the most distinguished leaders and personalities of our nation. And of course it's always good to come back to Riverside Church. Over the last eight years, I have had the privilege of preaching here almost every year in that period, and it's always a rich and rewarding experience to come to this great church and this great pulpit.

I come to this great magnificent house of worship tonight because my conscience leaves me no other choice. I join you in

this meeting because I am in deepest agreement with the aims and work of the organization that brought us together, Clergy and Laymen Concerned About Vietnam. The recent statements of your executive committee are the sentiments of my own heart, and I found myself in full accord when I read its opening lines: "A time comes when silence is betrayal." That time has come for us in relation to Vietnam.

The truth of these words is beyond doubt, but the mission to which they call us is a most difficult one. Even when pressed by the demands of inner truth, men do not easily assume the task of opposing their government's policy, especially in time of war. Nor does the human spirit move without great difficulty against all the apathy of conformist thought within one's own bosom and in the surrounding world. Moreover, when the issues at hand seem as perplexing as they often do in the case of this dreadful conflict, we are always on the verge of being mesmerized by uncertainty. But we must move on.

Some of us who have already begun to break the silence of the night have found that the calling to speak is often a vocation of agony, but we must speak. We must speak with all the humility that is appropriate to our limited vision, but we must speak. And we must rejoice as well, for surely this is the first time in our nation's history that a significant number of its religious leaders have chosen to move beyond the prophesying of smooth patriotism to the high grounds of a firm dissent based upon the mandates of conscience and the reading of history. Perhaps a new spirit is rising among us. If it is, let us trace its movement, and pray that our inner being may be sensitive to its guidance. For we are deeply in need of a new way beyond the darkness that seems so close around us.

Over the past two years, as I have moved to break the betrayal of my own silences and to speak from the burnings of my own heart, as I have called for radical departures from the destruction of Vietnam, many persons have questioned me about the wisdom of my path. At the heart of their concerns, this

query has often loomed large and loud: "Why are you speaking about the war, Dr. King? Why are you joining the voices of dissent?" "Peace and civil rights don't mix," they say. "Aren't you hurting the cause of your people?" they ask. And when I hear them, though I often understand the source of their concern, I am nevertheless greatly saddened, for such questions mean that the inquirers have not really known me, my commitment, or my calling. Indeed, their questions suggest that they do not know the world in which they live. In the light of such tragic misunderstanding, I deem it of signal importance to state clearly, and I trust concisely, why I believe that the path from Dexter Avenue Baptist Church—the Montgomery, Alabama, where in Ι my pastorate-leads clearly to this sanctuary tonight.

I come to this platform tonight to make a passionate plea to my beloved nation. This speech is not addressed to Hanoi or to the National Liberation Front. It is not addressed to China or to Russia. Nor is it an attempt to overlook the ambiguity of the total situation and the need for a collective solution to the tragedy of Vietnam. Neither is it an attempt to make North Vietnam or the National Liberation Front paragons of virtue, nor to overlook the role they must play in the successful resolution of the problem. While they both may have justifiable reasons to be suspicious of the good faith of the United States, life and history give eloquent testimony to the fact that conflicts are never resolved without trustful give and take on both sides. Tonight, however, I wish not to speak with Hanoi and the National Liberation Front, but rather to my fellow Americans.

Since I am a preacher by calling, I suppose it is not surprising that I have seven major reasons for bringing Vietnam into the field of my moral vision. There is at the outset a very obvious and almost facile connection between the war in Vietnam and the struggle I and others have been waging in America. A few years ago there was a shining moment in that

struggle. It seemed as if there was a real promise of hope for the poor, both black and white, through the poverty program. There were experiments, hopes, new beginnings. Then came the buildup in Vietnam, and I watched this program broken and eviscerated as if it were some idle political plaything on a society gone mad on war. And I knew that America would never invest the necessary funds or energies in rehabilitation of its poor so long as adventures like Vietnam continued to draw men and skills and money like some demonic, destructive suction tube. So I was increasingly compelled to see the war as an enemy of the poor and to attack it as such.

Perhaps a more tragic recognition of reality took place when it became clear to me that the war was doing far more than devastating the hopes of the poor at home. It was sending their sons and their brothers and their husbands to fight and to die in extraordinarily high proportions relative to the rest of the population. We were taking the black young men who had been crippled by our society and sending them eight thousand miles away to guarantee liberties in Southeast Asia which they had not found in southwest Georgia and East Harlem. So we have been repeatedly faced with the cruel irony of watching Negro and white boys on TV screens as they kill and die together for a nation that has been unable to seat them together in the same schools. So we watch them in brutal solidarity burning the huts of a poor village, but we realize that they would hardly live on the same block in Chicago. I could not be silent in the face of such cruel manipulation of the poor.

My third reason moves to an even deeper level of awareness, for it grows out of my experience in the ghettos of the North over the last three years, especially the last three summers. As I have walked among the desperate, rejected, and angry young men, I have told them that Molotov cocktails and rifles would not solve their problems. I have tried to offer them my deepest compassion while maintaining my conviction that social

change comes most meaningfully through nonviolent action. But they asked, and rightly so, "What about Vietnam?" They asked if our own nation wasn't using massive doses of violence to solve its problems, to bring about the changes it wanted. Their questions hit home, and I knew that I could never again raise my voice against the violence of the oppressed in the ghettos without having first spoken clearly to the greatest purveyor of violence in the world today: my own government. For the sake of those boys, for the sake of this government, for the sake of the hundreds of thousands trembling under our violence, I cannot be silent.

For those who ask the question, "Aren't you a civil rights leader?" and thereby mean to exclude me from the movement for peace, I have this further answer. In 1957, when a group of us formed the Southern Christian Leadership Conference, we chose as our motto: "To save the soul of America." We were convinced that we could not limit our vision to certain rights for black people, but instead affirmed the conviction that America would never be free or saved from itself until the descendants of its slaves were loosed completely from the shackles they still wear. In a way we were agreeing with Langston Hughes, that black bard from Harlem, who had written earlier:

0, yes, I say it plain,
America never was America to me,
And yet I swear this oath—
America will be!

Now it should be incandescently clear that no one who has any concern for the integrity and life of America today can ignore the present war. If America's soul becomes totally poisoned, part of the autopsy must read "Vietnam." It can never be saved so long as it destroys the hopes of men the world over. So it is that those of us who are yet determined that "America will be" are led down the path of protest and dissent, working for the health of our land.

As if the weight of such a commitment to the life and health of America were not enough, another burden of responsibility was placed upon me in 1954.\* And I cannot forget that the Nobel Peace Prize was also a commission, a commission to work harder than I had ever worked before for the brotherhood of man. This is a calling that takes me beyond national allegiances.

But even if it were not present, I would yet have to live with the meaning of my commitment to the ministry of Jesus Christ. To me, the relationship of this ministry to the making of peace is so obvious that I sometimes marvel at those who ask me why I am speaking against the war. Could it be that they do not know that the Good News was meant for all men-for communist and capitalist, for their children and ours, for black and for white, for revolutionary and conservative? Have they forgotten that my ministry is in obedience to the one who loved his enemies so fully that he died for them? What then can I say to the Vietcong or to Castro or to Mao as a faithful minister of this one? Can I threaten them with death or must I not share with them my life?

Finally, as I try to explain for you and for myself the road that leads from Montgomery to this place, I would have offered all that was most valid if I simply said that I must be true to my conviction that I share with all men the calling to be a son of the living God. Beyond the calling of race or nation or creed is this vocation of sonship and brotherhood. Because I believe that the Father is deeply concerned, especially for His suffering and helpless and outcast children, I come tonight to speak for them. This I believe to be the privilege and the burden of all of us who deem ourselves bound by allegiances and loyalties which are broader and deeper than nationalism and which go beyond our nation's self-defined goals and positions. We are called to speak for the weak, for the voiceless, for the victims of our nation, for those it calls "enemy," for no document from human hands can make these

#### humans any less our brothers.

And as I ponder the madness of Vietnam and search within myself for ways to understand and respond in compassion, my mind goes constantly to the people of that peninsula. I speak now not of the soldiers of each side, not of the ideologies of the Liberation Front, not of the junta in Saigon, but simply of the people who have been living under the curse of war for almost three continuous decades now. I think of them, too, because it is clear to me that there will be no meaningful solution there until some attempt is made to know them and hear their broken cries.

They must see Americans as strange liberators. The Vietnamese people proclaimed their own independence in 1954-in 1945 rather—after a combined French and Japanese occupation and before the communist revolution in China. They were led by Ho Chi Minh. Even though they quoted the American Declaration of Independence in their own document of freedom, we refused to recognize them. Instead, we decided to support France in its reconquest of her former colony. Our government felt then that the Vietnamese people were not ready for independence, and we again fell victim to the deadly Western arrogance that has poisoned the international atmosphere for so long. With that tragic decision we rejected a revolutionary government seeking self-determination and a government that had been established not by China-for whom the Vietnamese have no great love-but by clearly indigenous forces that included some communists. For the peasants this new government meant real land reform, one of the most important needs in their lives.

For nine years following 1945 we denied the people of Vietnam the right of independence. For nine years we vigorously supported the French in their abortive effort to recolonize Vietnam. Before the end of the war we were meeting eighty percent of the French war costs. Even before the French were defeated at Dien Bien Phu, they began to despair of their reckless action, but we did not. We encouraged them with our

huge financial and military supplies to continue the war even after they had lost the will. Soon we would be paying almost the full costs of this tragic attempt at recolonization.

After the French were defeated, it looked as if independence and land reform would come again through the Geneva Agreement. But instead there came the United States, determined that Ho should not unify the temporarily divided nation, and the peasants watched again as we supported one of the most vicious modern dictators, our chosen man, Premier Diem. The peasants watched and cringed and Diem ruthlessly rooted out all opposition, supported their extortionist landlords, and refused even to discuss reunification with the North. The peasants watched as all of this was presided over by United States influence and then by increasing numbers of United States troops who came to help quell the insurgency that Diem's methods had aroused. When Diem was overthrown they may have been happy, but the long line of military dictators seemed to offer no real change, especially in terms of their need for land and peace.

The only change came from America as we increased our troop commitments in support of governments which were singularly corrupt, inept, and without popular support. All the while the people read our leaflets and received the regular promises of peace and democracy and land reform. Now they languish under our bombs and consider us, not their fellow Vietnamese, the real enemy. They move sadly and apathetically as we herd them off the land of their fathers into concentration camps where minimal social needs are rarely met. They know they must move on or be destroyed by our bombs.

So they go, primarily women and children and the aged. They watch as we poison their water, as we kill a million acres of their crops. They must weep as the bulldozers roar through their areas preparing to destroy the precious trees. They wander into the hospitals with at least twenty casualties from American firepower for one Vietcong-inflicted injury. So far

we may have killed a million of them, mostly children. They wander into the towns and see thousands of the children, homeless, without clothes, running in packs on the streets like animals. They see the children degraded by our soldiers as they beg for food. They see the children selling their sisters to our soldiers, soliciting for their mothers.

What do the peasants think as we ally ourselves with the landlords and as we refuse to put any action into our many words concerning land reform? What do they think as we test out our latest weapons on them, just as the Germans tested out new medicine and new tortures in the concentration camps of Europe? Where are the roots of the independent Vietnam we claim to be building? Is it among these voiceless ones?

We have destroyed their two most cherished institutions: the family and the village. We have destroyed their land and their crops. We have cooperated in the crushing of the nation's only noncommunist revolutionary political force, the unified Buddhist Church. We have supported the enemies of the peasants of Saigon. We have corrupted their women and children and killed their men.

Now there is little left to build on, save bitterness. Soon the only solid physical foundations remaining will be found at our military bases and in the concrete of the concentration camps we call "fortified hamlets." The peasants may well wonder if we plan to build our new Vietnam on such grounds as these. Could we blame them for such thoughts? We must speak for them and raise the questions they cannot raise. These, too, are our brothers.

Perhaps a more difficult but no less necessary task is to speak for those who have been designated as our enemies. What of the National Liberation front, that strangely anonymous group we call "VC" or "communists"? What must they think of the United States of America when they realize that we permitted the repression and cruelty of Diem, which helped to

bring them into being as a resistance group in the South? What do they think of our condoning the violence which led to their own taking up of arms? How can they believe in our integrity when now we speak of "aggression from the North" as if there was nothing more essential to the war? How can they trust us when now we charge them with violence after the murderous reign of Diem and charge them with violence while we pour every new weapon of death into their land? Surely we must understand their feelings, even if we do not condone their actions. Surely we must see that the men we supported pressed them to their violence. Surely we must see that our own computerized plans of destruction simply dwarf their greatest acts.

How do they judge us when our officials know that their membership is less than twenty-five percent communist, and yet insist on giving them the blanket name? What must they be thinking when they know that we are aware of their control of major sections of Vietnam, and yet we appear ready to allow national elections in which this highly organized political parallel government will not have a part? They ask how we can speak of free elections when the Saigon press is censored and controlled by the military junta. And they are surely right to wonder what kind of new government we plan to help form without them, the only real party in real touch with the peasants. They question our political goals and they deny the reality of a peace settlement from which they will be excluded. Their questions are frighteningly relevant. Is our nation planning to build on political myth again, and then shore it up upon the power of a new violence?

Here is the true meaning and value of compassion and nonviolence, when it helps us to see the enemy's point of view, to hear his questions, to know his assessment of ourselves. For from his view we may indeed see the basic weaknesses of our own condition, and if we are mature, we may learn and grow and profit from the wisdom of the brothers who

are called the opposition.

Also, it must be clear that the leaders of Hanoi considered the presence of American troops in support of the Diem regime to have been the initial military breach of the Geneva Agreement concerning foreign troops. They remind us that they did not begin to send troops in large numbers and even supplies into the South until American forces had moved into the tens of thousands. So, too, with Hanoi. In the North, where our bombs now pummel the land, and our mines endanger the waterways, we are met by a deep but understandable mistrust. To speak for them is to explain this lack of confidence in Western worlds, and especially their distrust of American intentions now. In Hanoi are the men who led this nation to independence against the Japanese and the French, the men who sought membership in the French Commonwealth and were betrayed by the weakness of Paris and the willfulness of the colonial armies. It was they who led a second struggle against French domination at tremendous costs, and then were persuaded to give up the land they controlled between the thirteenth and seventeenth parallel as a temporary measure at Geneva. After 1954 they watched us conspire with Diem to prevent elections which could have surely brought Ho Chi Minh to power over a unified Vietnam, and they realized they had been betrayed again. When we ask why they do not leap to negotiate, these things must be considered.

Hanoi remembers how our leaders refused to tell us the truth about the earlier North Vietnamese overtures for peace, how the president claimed that none existed when they had clearly been made. Ho Chi Minh has watched as America has spoken of peace and built up its forces, and now he has surely heard the increasing international rumors of American plans for an invasion of the north. He knows the bombing and shelling and mining we are doing are part of traditional pre-invasion strategy. Perhaps only his sense of humor and of irony can save him when he hears the most powerful nation of the world

speaking of aggression as it drops thousands of bombs on a poor, weak nation more than eight hundred, or rather, eight thousand miles away from its shores.

At this point I should make it clear that while I have tried to give a voice to the voiceless in Vietnam and to understand the arguments of those who are called "enemy," I am as deeply concerned about our own troops there as anything else. For it occurs to me that what we are submitting them to in Vietnam is not simply the brutalizing process that goes on in any war where armies face each other and seek to destroy. We are adding cynicism to the process of death, for they must know after a short period there that none of the things we claim to be fighting for are really involved. Before long they must know that their government has sent them into a struggle among Vietnamese, and the more sophisticated surely realize that we are on the side of the wealthy, and the secure, while we create a hell for the poor.

Surely this madness must cease. We must stop now. I speak as a child of God and brother to the suffering poor of Vietnam. I speak for those whose land is being laid waste, whose homes are being destroy, whose culture is being subverted. I speak for the poor in America who are paying the double price of smashed hopes at home, and dealt death and corruption in Vietnam. I speak as a citizen of the world, for the world as it stands aghast at the path we have taken. I speak as one who loves America, to the leaders of our own nation: The great initiative in this war is ours; the initiative to stop it must be ours.

This is the message of the great Buddhist leaders of Vietnam. Recently one of them wrote these words, and I quote:

Each day the war goes on the hatred increased in the hearts of the Vietnamese and in the hearts of those of humanitarian instinct. The Americans are forcing even their friends into becoming their enemies. It is curious that the Americans, who calculate so carefully on the possibilities of military victory, do not realize that in the process they are incurring deep psychological and political defeat. The image of America will never again be the image of revolution, freedom, and democracy, but the image of violence and militarism.

#### Unquote.

If we continue, there will be no doubt in my mind and in the mind of the world that we have no honorable intentions in Vietnam. If we do not stop our war against the people of Vietnam immediately, the world will be left with no other alternative than to see this as some horrible, clumsy, and deadly game we have decided to play. The world now demands a maturity of America that we may not be able to achieve. It demands that we admit we have been wrong from the beginning of our adventure in Vietnam, that we have been detrimental to the life of the Vietnamese people. The situation is one in which we must be ready to turn sharply from our present ways. In order to atone for our sins and errors in Vietnam, we should take the initiative in bringing a halt to this tragic war.

I would like to suggest five concrete things that our government should do to begin the long and difficult process of extricating ourselves from this nightmarish conflict:

Number one: End all bombing in North and South Vietnam.

Number two: Declare a unilateral cease-fire in the hope that such action will create the atmosphere for negotiation.

Three: Take immediate steps to prevent other battlegrounds in Southeast Asia by curtailing our military buildup in Thailand and our interference in Laos.

Four: Realistically accept the fact that the National Liberation Front has substantial support in South Vietnam and must thereby play a role in any meaningful negotiations and any future Vietnam government. Five: Set a date that we will remove all foreign troops from Vietnam in accordance with the 1954 Geneva Agreement. [sustained applause]

Part of our ongoing [applause continues], part of our ongoing commitment might well express itself in an offer to grant asylum to any Vietnamese who fears for his life under a new regime which included the Liberation Front. Then we must make what reparations we can for the damage we have done. We must provide the medical aid that is badly needed, making it available in this country if necessary. Meanwhile [applause], meanwhile, we in the churches and synagogues have a continuing task while we urge our government to disengage itself from a disgraceful commitment. We must continue to raise our voices and our lives if our nation persists in its perverse ways in Vietnam. We must be prepared to match actions with words by seeking out every creative method of protest possible.

As we counsel young men concerning military service, we must clarify for them our nation's role in Vietnam and challenge them with the alternative of conscientious objection. [sustained applause] I am pleased to say that this is a path now chosen by more than seventy students at my own alma mater, Morehouse College, and I recommend it to all who find the American course in Vietnam a dishonorable and unjust one. [applause] Moreover, I would encourage all ministers of draft age to give up their ministerial exemptions and seek status as conscientious objectors. [applause] These are the times for real choices and not false ones. We are at the moment when our lives must be placed on the line if our nation is to survive its own folly. Every man of humane convictions must decide on the protest that best suits his convictions, but we must all protest.

Now there is something seductively tempting about stopping there and sending us all off on what in some circles has become a popular crusade against the war in Vietnam. I say we must enter that struggle, but I wish to go on now to say something even more disturbing.

The war in Vietnam is but a symptom of a far deeper malady within the American spirit, and if we ignore this sobering reality [applause], and if we ignore this sobering reality, we will find ourselves organizing "clergy and laymen concerned" committees for the next generation. They will be concerned about Guatemala and Peru. They will be concerned about Thailand and Cambodia. They will be concerned about Mozambique and South Africa. We will be marching for these and a dozen other names and attending rallies without end unless there is a significant and profound change in American life and policy. [sustained applause] So such thoughts take us beyond Vietnam, but not beyond our calling as sons of the living God.

In 1957 a sensitive American official overseas said that it seemed to him that our nation was on the wrong side of a world revolution. During the past ten years we have seen emerge a pattern of suppression which has now justified the presence of U.S. military advisors in Venezuela. This need to maintain social stability for our investments accounts for the counterrevolutionary action of American forces in Guatemala. It tells why American helicopters are being used against guerrillas in Cambodia and why American napalm and Green Beret forces have already been active against rebels in Peru.

It is with such activity that the words of the late John F. Kennedy come back to haunt us. Five years ago he said, "Those who make peaceful revolution impossible will make violent revolution inevitable." [applause] Increasingly, by choice or by accident, this is the role our nation has taken, the role of those who make peaceful revolution impossible by refusing to give up the privileges and the pleasures that come from the immense profits of overseas investments. I am convinced that if we are to get on to the right side of the world revolution, we as a nation must undergo a radical revolution of values. We must rapidly begin [applause], we must rapidly begin the shift from a thing-oriented society to a person-oriented society.

When machines and computers, profit motives and property rights, are considered more important than people, the giant triplets of racism, extreme materialism, and militarism are incapable of being conquered.

A true revolution of values will soon cause us to question the fairness and justice of many of our past and present policies. On the one hand we are called to play the Good Samaritan on life's roadside, but that will be only an initial act. One day we must come to see that the whole Jericho Road must be transformed so that men and women will not be constantly beaten and robbed as they make their journey on life's highway. True compassion is more than flinging a coin to a beggar. It comes to see than an edifice which produces beggars needs restructuring. [applause]

A true revolution of values will soon look uneasily on the glaring contrast of poverty and wealth. With righteous indignation, it will look across the seas and see individual capitalists of the West investing huge sums of money in Asia, Africa, and South America, only to take the profits out with no concern for the social betterment of the countries, and say, "This is not just." It will look at our alliance with the landed gentry of South America and say, "This is not just." The Western arrogance of feeling that it has everything to teach others and nothing to learn from them is not just.

A true revolution of values will lay hand on the world order and say of war, "This way of settling differences is not just." This business of burning human beings with napalm, of filling our nation's homes with orphans and widows, of injecting poisonous drugs of hate into the veins of peoples normally humane, of sending men home from dark and bloody battlefields physically handicapped and psychologically deranged, cannot be reconciled with wisdom, justice, and love. A nation that continues year after year to spend more money on military defense than on programs of social uplift is approaching spiritual death. [sustained applause]

America, the richest and most powerful nation in the world, can well lead the way in this revolution of values. There is nothing except a tragic death wish to prevent us from reordering our priorities so that the pursuit of peace will take precedence over the pursuit of war. There is nothing to keep us from molding a recalcitrant status quo with bruised hands until we have fashioned it into a brotherhood.

This kind of positive revolution of values is our best defense against communism. [applause] War is not the answer. Communism will never be defeated by the use of atomic bombs or nuclear weapons. Let us not join those who shout war and, through their misguided passions, urge the United States to relinquish its participation in the United Nations. These are days which demand wise restraint and calm reasonableness. We must not engage in a negative anticommunism, but rather in a positive thrust for democracy [applause], realizing that our greatest defense against communism is to take offensive action in behalf of justice. We must with positive action seek to remove those conditions of poverty, insecurity, and injustice, which are the fertile soil in which the seed of communism grows and develops.

These are revolutionary times. All over the globe men are revolting against old systems of exploitation and oppression, and out of the wounds of a frail world, new systems of justice and equality are being born. The shirtless and barefoot people of the land are rising up as never before. The people who sat in darkness have seen a great light. We in the West must support these revolutions.

It is a sad fact that because of comfort, complacency, a morbid fear of communism, and our proneness to adjust to injustice, the Western nations that initiated so much of the revolutionary spirit of the modern world have now become the arch antirevolutionaries. This has driven many to feel that only Marxism has a revolutionary spirit. Therefore, communism is a judgment against our failure to make democracy real and

follow through on the revolutions that we initiated. Our only hope today lies in our ability to recapture the revolutionary spirit and go out into a sometimes hostile world declaring eternal hostility to poverty, racism, and militarism. With this powerful commitment we shall boldly challenge the status quo and unjust mores, and thereby speed the day when "every valley shall be exalted, and every mountain and hill shall be made low [Audience:] (Yes); the crooked shall be made straight, and the rough places plain."

A genuine revolution of values means in the final analysis that our loyalties must become ecumenical rather than sectional. Every nation must now develop an overriding loyalty to mankind as a whole in order to preserve the best in their individual societies.

This call for a worldwide fellowship that lifts neighborly concern beyond one's tribe, race, class, and nation is in reality a call for an all-embracing and unconditional love for all mankind. This oft misunderstood, this oft misinterpreted concept, so readily dismissed by the Nietzsches of the world as a weak and cowardly force, has now become an absolute necessity for the survival of man. When I speak of love I am not speaking of some sentimental and weak response. I'm not speaking of that force which is just emotional bosh. I am speaking of that force which all of the great religions have seen as the supreme unifying principle of life. Love is somehow the key that unlocks the door which leads to ultimate reality. This Hindu-Muslim-Christian-Jewish-Buddhist belief about ultimate reality is beautifully summed up in the first epistle of Saint John: "Let us love one another (Yes), for love is God. (Yes) And every one that loveth is born of God and knoweth God. He that loveth not knoweth not God, for God is love. . . . If we love one another, God dwelleth in us and his love is perfected in us." Let us hope that this spirit will become the order of the day.

We can no longer afford to worship the god of hate or bow

before the altar of retaliation. The oceans of history are made turbulent by the ever-rising tides of hate. History is cluttered with the wreckage of nations and individuals that pursued this self-defeating path of hate. As Arnold Toynbee says: "Love is the ultimate force that makes for the saving choice of life and good against the damning choice of death and evil. Therefore the first hope in our inventory must be the hope that love is going to have the last word." Unquote.

We are now faced with the fact, my friends, that tomorrow is today. We are confronted with the fierce urgency of now. In this unfolding conundrum of life and history, there is such a thing as being too late. Procrastination is still the thief of time. Life often leaves us standing bare, naked, and dejected with a lost opportunity. The tide in the affairs of men does not remain at flood—it ebbs. We may cry out desperately for time to pause in her passage, but time is adamant to every plea and rushes on. Over the bleached bones and jumbled residues of numerous civilizations are written the pathetic words, "Too late." There is an invisible book of life that faithfully records our vigilance or our neglect. Omar Khayyam is right: "The moving finger writes, and having writ moves on."

We still have a choice today: nonviolent coexistence or violent coannihilation. We must move past indecision to action. We must find new ways to speak for peace in Vietnam and justice throughout the developing world, a world that borders on our doors. If we do not act, we shall surely be dragged down the long, dark, and shameful corridors of time reserved for those who possess power without compassion, might without morality, and strength without sight.

Now let us begin. Now let us rededicate ourselves to the long and bitter, but beautiful, struggle for a new world. This is the calling of the sons of God, and our brothers wait eagerly for our response. Shall we say the odds are too great? Shall we tell them the struggle is too hard? Will our message be that the forces of American life militate against their arrival as full men, and we send our deepest regrets? Or will there be another message—of longing, of hope, of solidarity with their yearnings, of commitment to their cause, whatever the cost? The choice is ours, and though we might prefer it otherwise, we must choose in this crucial moment of human history.

As that noble bard of yesterday, James Russell Lowell, eloquently stated:

Once to every man and nation comes a moment do decide,

In the strife of truth and Falsehood, for the good or evil side;

Some great cause, God's new Messiah offering each the bloom or blight,

And the choice goes by forever 'twixt that darkness and that light.

Though the cause of evil prosper, yet 'tis truth alone is strong

Though her portions be the scaffold, and upon the throne be wrong

Yet that scaffold sways the future, and behind the dim unknown

Standeth God within the shadow, keeping watch above his own.

And if we will only make the right choice, we will be able to transform this pending cosmic elegy into a creative psalm of peace. If we will make the right choice, we will be able to transform the jangling discords of our world into a beautiful symphony of brotherhood. If we will but make the right choice, we will be able to speed up the day, all over America and all over the world, when justice will roll down like waters, and righteousness like a mighty stream. [sustained applause]

#### **Unofficial Transcript:**

...But we're not going to do that today. We're going to do something very simple.

I've got three messages for you.

The first message is very simple:

Nature has never and will never conspire against humanity. Nature loves humanity and nature loves humans.

The only things that conspire against humanity are humans who have sold their souls.

Our job today is very simple. And for those of you who don't get the memo, the great news is there's a print copy of the memo.

But, for the record, I am actually standing in front of the senate office building and I'm actually going to read the crimes — and I mean literal crimes — against humanity perpetrated by Dr. Anthony Fauci, by Dr. Robert Redfield, and by Mr. Alex M. Azar, the Secretary of Health and Human Services.

These are crimes and these, in the first instance, are felony crimes — resulting in jail time and fines.

And, not one office of inspector general, not one attorney general, and not one US attorney for any district in this country has had the courage that I have on this stage today.

Dr. Anthony Fauci, Dr. Redfield and Mr. Azar have done the following crimes against the United States and against the citizens of the world.

They have violated 18 U.S. Code, Section 2339 in funding and conspiring to take engage in acts of terror against the citizens of the United States. That is a felony.

They have engaged in a violation which is a felony of 18 U.S. Code, Section 2331, Section 802 of the Patriot Act, where they have willfully lied and manipulated and coerced the population to induce fear in that population for their self-interest. That is a felony violation.

They have, in fact, in October of 2020, lied to Congress — a felony violation of 18 U.S. Code Section 1001.

In violation of 15 U.S. Code, Section 1 through 3, they have conspired to commit criminal activities by appropriating US taxpayer dollars, to fund those taxpayer dollars into their market-selected corporate interests, including Moderna, and

Pfizer, and Gilead Sciences, and a whole host of others.

In violation of 15 U.S. Code, Section 8, they have engaged in market manipulation and market allocation by price fixing the prices of vaccines and therapeutic interventions for COVID-19.

In violation of 15 U.S. Code Section 19, they have actually violated a federal felony crime of interlocking directorates — controlling both the means, the motive, and the message around what is, in fact, the COVID-19 campaign.

Those are criminal violations. Those are things for which they should be arrested, cuffed and taken into custody right now.

And, if anyone within the hearing of my voice here, or anywhere else, has courage and has a freakin' drop of patriot blood in them, they have an obligation under the oath that they take to protect and defend this Constitution, to bring these criminals to justice. And on their way, they can actually charge them for the civil complaints as well.

Violation of 35 U.S. Code, Section 206, which is the disclosure of government interests. In fact, Dr. Anthony Fauci on October of 2020 failed to disclose 40 patents generating over 4.5 billion dollars a year that he is actually directly benefitting from in NIAID and NIH's response to the office of the general accountability office investigation into NIH.

They have violated Section 35, Section 101 of the patent laws of the United States by patenting nature, which is actually a violation of the fundamental rights of patent laws in the United States. And finally, in violation of 21 Code of Federal Regulations.

And, by the way, this goes to everybody standing here, and everybody around the country, they have forced us to participate in a clinical trial in violation of 21 CFR and in violation of the Nuremberg code.

They have actually forced us to participate in a clinical trial and violated the federal trade commission laws that say that you actually cannot promote the treatment or prevention of disease by an untested medical technology.

As recently as April of 2020, the actual journal of medical association said there was no evidence, no scientific evidence, that masks did anything to prevent or treat or ameliorate any form of disease.

But against the law - and it's 21 CFR, Section 50.24 and following, they violated the law and they violated the federal trade commission act that says you're not allowed to do that.

That is the same act that they have used to shut down natural medicine solutions for the last 115 years.

And it's time we throw their own law back in their face. This is about actually holding people accountable to their own thing.

Now, that's part two.

Here's part three:

You've been lied to. And you've been lied to time and time and time again.

But I'm going to bring you some evidence. And this is evidence that you never saw before.

This little book here is actually a book I published in May of 2005. And, in it, I have the evidence that the programs that Anthony Fauci has funded and supported are, not only, not in the interest of health, but worse than that, they are part of bioweapons programs.

And what we are experiencing right now is not an accident of nature. It is the willful virulent enhancement of a pathogen that has been unleashed for the purpose of destroying this

country.

This is an act of war. This is not just a treasonous act, this is an act of war.

And, in this book, on page 76, I actually have the evidence that the United States Department of Defense actually patented the weaponization of biologic agents at the exact same <u>BSL facilities</u>. They are the same facilities where the coronavirus allegedly was amplified.

This particular document details — are you ready for this — the blast-resistance, so that a pathogen could be placed in a rocket-propelled grenade. Does that sound like an injection? # Family Farm in Maine Couldn't Make it After Restaurants Close — Until the Neighbors Showed Up

In 1996, organic farmers Ralph and Lisa Turner launched Laughing Stock Farm on one-fifth of an acre in Freeport, Maine. With trial and error eventually came success, a steady customer base, and 12-and-a-half more acres.

"Our quality produce coupled with your commitment to purchasing fresh local vegetables has built our business into a sustainable family-owned farm that will be able to serve you for years to come," <a href="their website">their website</a> proudly states.

When the pandemic hit last year, as suppliers to Portland area restaurants forced to close, that future seemed very much in jeopardy. Their main source of income was suddenly gone. Left behind, eight overflowing greenhouses plus 10 tons of veggies in cold storage of supply—and zero demand.

Zero sales translated to zero cash flow.

With money already invested in produce they couldn't sell, a loss seemed inevitable and breaking even only a pipe dream. But rather than ditch the harvest, the Turners, who are both trained engineers, went back to the blackboard and came up with a Plan B.

The couple opened a farm stand, selling pre-bagged produce at \$3 a pop, and sent out word via their company newsletter.

"We bagged up stuff as if we were going to have maybe 10 people a day come," Lisa told <u>The New York Times</u>. "We sent it out to probably 450 email addresses—and then people just started sharing it and sharing it and sharing it. The first day it was like, wow, that was a lot of people... The eggs were flying out of here... We went through 130 dozen eggs in two and a half days. It was insane."

Realizing they were on to something, Lisa contacted a local beef farmer and set up a delivery. She says with customers clamoring for steak left and right, the initial 40-pound delivery never even made it to the freezer.

Even more astonishing was that customers started leaving generous tips from folks who wanted to show their support and keep the farm solvent until the next planting season.

Lisa likened the experience to the climactic scene in Frank Capra's 1946 Christmas classic It's a Wonderful Life when a parade of thankful townspeople show up to shower George Bailey (played by Jimmy Stewart) with enough cash to stop his beloved family Building & Loan company from going under.

When all was said and done, the Turners didn't make a huge profit, but they were able keep themselves in the black financially. In the coming year, they've pivoted their business model. In addition to growing and selling their own crops, they'll be running a farm store featuring their own organic wares along with goods from other local meat and dairy distributors.

While they can't be sure they'll succeed in their new endeavor, they do have cause for cautious hope. Of all the Christmases she's lived through, the one just past has truly put things in perspective for Lisa. The support and kindness she and her husband received from friends and strangers was both a blessing and an affirmation.

"There's a lot to be thankful for," Lisa said. "And it's an antidote to fear."

#### **Excerpts:**

"Our focus is on the PCR test because if we manage to convince a court of law that this is a fraudulent enterprise — the PCR test being marketed with the assertion that it can detect infections. If we can convince a court of law that this is a false statement, then the whole house of cards is going to come crashing down because there's nothing else.

That is the tool that they're that they're using in order to keep people in panic mode. And there's no basis for this panic because, as I just pointed out, even according to the WHO which couldn't quite escape the conclusions of John Ioannidis, the mortality is, or lethality is, roughly the same as that of the common flu."

"And also there's already herd immunity. That's another thing that has been overlooked. So there's absolutely no reason for vaccines except for the pharmaceutical industry to make money and probably cause a lot of damage as far as health. And even there's probably going to be a lot of fatalities too because these vaccines haven't really been tested properly."

"This is not gonna be one single lawsuit. It's gonna be a number of different lawsuits that are going to be filed both on here in Germany on this side of the Atlantic and in the United States."

"The intent is, or the intention that we think is important here, is to uncover the whole thing— to use what we've learned through the corona committee— to use these pieces of evidence and the experts that we've heard in order to convince a court of law that this is a staged pandemic and that there's other goals, other people who are behind this, and trying to push completely different goals. This has nothing to do with the world's health."

"We know that there's something in the background but it's not important for our lawsuit. For a lawsuit, we can concentrate on one thing only. These people lied when they're telling the general public that PCR tests can tell us something about infections. "

"...but trying to use fear so that people will believe everyone, even their closest neighbors and relatives is a danger to them could be a super spreader, even if they're completely healthy and show no symptoms. "One of the law professors who advises us in the background pointed out to me, in this tort case there are two really important lies that have to be put front and center: One is PCR tests can tell us something about infections. "Lie number one, you cannot tell anything about infections by using these PCR tests because what they do is they test positive to almost everything, including, for example the debris, the fragments, of a common cold, of of your immune system's fight against the common cold.

Lie number two, even more important I think, is — he says that there are asymptomatic infections. Which basically means anyone who is surrounding us, our relatives, our friends, and who shows no symptoms, who's perfectly healthy or appears perfectly healthy, could be a threat. That's what this induces. That's what this fraud — there are asymptomatic infections — induces. It tells us, 'oh my god, everybody could be potentially dangerous'. That is not true."

"We have had not just lawyers who are trying to help, more and more lawyers who are coming out of hiding more or less, but we've also — The Corona Committee, that is — we've also had judges calling us, getting in touch with us, and asking us how they can help. "

Welcome to the year-end wrap up! You know, the annual end-ofyear stock-taking editorial I write before we all go off to enjoy our Christmas and ring in the New Year?

Now, if this were any other year, I'd make some light-hearted joke about all of this. You know, "Oh, nothing much happened this year, there's really nothing to write about." Or: "It's like the opening of *A Tale of Two Cities* except without the 'best of times' bit."

But this is not any other year. This is 2020. So I'm resorting to quoting Queen Elizardbeast. Remember what she said about

#### 1992?

"In the words of one of my more sympathetic correspondents, it has turned out to be an *annus horribilis*."

Queeny was whining about all the scandals and "tragedies" that befell her poor family that year, of course, like her childrens' philandering being exposed to the world and Her Majesty herself being pelted with eggs by angry Germans and her multi-million pound castle catching fire.

I'll cue the world's smallest violin as you wipe the tears from your eyes.

The backlash against Governor Gavin Newsom's stay-at-home order is growing after it was revealed that Sheriffs in counties that represent 40 percent of California's population say they won't enforce his coronavirus restrictions.

Newsom's shutdown of children's playgrounds and outdoor dining has prompted fury, with business owners saying they are being unfairly punished.

Thanks to hypocritical governor Gavin Newsom's tyrannical lockdown in the state of California, 1 in every 3 California restaurants will be <u>permanently closing</u> their doors this year. Other states, like New York, Michigan, Pennsylvania and

Minnesota face similar fates while most states across America have suffered massive layoffs in the restaurant industry.

The latest Bureau of Labor Statistics report on December 4 showed employment in leisure and hospitality is down by 3.4 million jobs since February. About 17,000 jobs in "food services and drinking places" were cut in November alone.

As government continues to prove its incompetence, those in the private industry are stepping in to help. Food Network personality Guy Fieri worked to raise more than \$21.5 million over the last seven weeks to help unemployed restaurant workers.

His work has led to many folks praising him online, correctly

stating that he is "doing more than Congress" to aid struggling workers during the pandemic.

"Guy Fieri has raised \$21.5 million for unemployed restaurant workers, which means Guy Fieri has done more for unemployed restaurant workers than Congress has in the last 8 months," tweeted author Dan Price.

".@GuyFieri has raised more than \$21.5 million in seven weeks to assist unemployed restaurant workers. Shame on every single one of our government 'leaders' who have failed them. God bless the 'Fundraiser of Flavortown,'" tweeted Janice Dean, senior meteorologist at Fox News.

#### As Newsweek <u>reports:</u>

The longtime TV host of Diners, Drive-Ins and Dives made personal pleas with large corporate sponsors, including PepsiCo, Uber Eats and Moët Hennessy USA, to support his Restaurant Employee Relief Fund. Fieri started the fund on March 27 as the COVID-19 pandemic was rapidly spreading through the U.S. and much of the world. The group has helped more than 43,000 restaurant workers "who have suffered financially due to the COVID-19 health and economic crisis," particularly through \$500 grants to restaurant workers in every state.

Over the weekend, Fieri took it a step further and joined the resistance against the lockdowns. He announced his support from the CRA lawsuit mentioned above.

"We gotta keep Flavortown open for biz!" Fieri tweeted.

Fieri is obviously passionate about food but noted that restaurants are more than just food — they are the "heart and soul" of America.

"I've traveled coast to coast visiting thousands of restaurants across the country on Diners, Drive-Ins and

Dives, and after all the time on the road, it's clear that restaurants are the heart and soul of their communities," Fieri said in a statement released through the Discovery Channel last week. "When the COVID-19 pandemic hit, the impact on the restaurant industry was immediate. Restaurant Hustle 2020: All On The Line provides a real and intimate first-hand look into the lives of four top restaurateurs [as they] navigate through it all."

As government employees continue to collect their paychecks, while failing the people who pay their exorbitant salaries, it is heartening to see the private industry step in to help. Sadly, however, because of the damage done by the lockdowns, \$21.5 million is a drop in the bucket of what is actually needed. The only thing that will save the "heart and soul" of America now will be government reversing course — which is not at all likely — or massive resistance, which is already happening.
