Ericsson Stops Weekend Installation Due to 5G Protests. Warns Investors about Potential Liability for Exposure

5G opposition is worldwide. Cities AND countries have taken action to ban, delay, and halt deployment due to health and safety risks and warnings (see 1, 2, 3, 4, 5, 6. 7. 8, 9). Since 2018, there have been reports of people and animals becoming sick after it was turned on (see 1. 2, 3, 4).

Of course, <u>all sources of wireless exposure</u> can make people sick – Bluetooth, cell phone radiation and WiFi – not just 5G. All telecom companies have been <u>warning investors about</u> <u>liability</u> for many years – not just Ericsson.

5.3 Potential health risks related to radiofrequency electromagnetic fields may subject us to various product liability claims and result in regulatory changes.

The mobile telecommunications industry is subject to claims that mobile devices and other equipment that generate radiofrequency electromagnetic fields may expose users to health risks. At present, a substantial number of scientific reviews conducted by various independent research bodies have concluded that radiofrequency electromagnetic fields, at levels within the limits prescribed by public health authority safety standards and recommendations, cause no adverse effects to human health. However, any perceived risk or new scientific findings of adverse health effects from mobile communication devices and equipment could adversely affect us through a reduction in sales or through liability claims. Although Ericsson's products are designed to comply with currently applicable safety standards and regulations regarding radio frequency electromagnetic fields, we cannot guarantee that we will not become the subject of product liability claims or be held liable for such claims or be required to comply with future changed regulatory requirements that may have an adverse effect on our business, operating results, financial condition, reputation and brand.

Fortunately, Ericsson has stopped 5G installation though for the weekend due to protests.

Ericsson said its U.S. and Canadian field staff will not be doing any on-site work over the weekend except in the case of emergencies after reports surfaced that 5G protests are planned.

NATE: The Communications Infrastructure Contractors Association issued an advisory to its members Thursday about Global 5G Protest Day activities reportedly planned for this Saturday, June 6.

"NATE as an organization has heard through official channels that there are 5G Global Protest Day activities being planned throughout the country this Saturday, June 6, 2020," the <u>advisory states</u>. "NATE reminds our member companies and their employees to remain safe, exercise vigilance and report any unusual or suspicious activities that they witness when traveling to and working at tower sites this weekend."

NATE's bulletin came after the U.S. Department of Homeland Security issued a warning several weeks ago to telecom companies, wireless contractors and the technician workforce that cell tower/wireless infrastructure sites could be potentially subject to attacks based on some incidents at tower sites around the world, including Canada. Earlier this year, numerous cell towers in the Memphis, Tennessee, area were <u>set on fire</u>.

It's against this backdrop that NATE has been closely monitoring social media activities and issued the warning, according to NATE President and CEO Todd Schlekeway. NATE also has heard directly from many of its members, including wireless carriers, tower owners and large general contractors, about exercising caution and additional planning due to the Global 5G Protest Day scheduled for Saturday.
