it very loudly, so that the question could not be missed. And the general's answer was "Yes."

In reading the article, however, the possibility of kinetic "rod of God" weapons is not even mentioned, and the narrative is steered once again to conventional weapons:

Nuclear arms control expert Jon Wolfsthal, who served as a special assistant to former President Barack Obama from 2014 to 2017, raised the possibility that Trump does not know what he is talking about.

"Nuclear weapons remain the most powerful weapons in the US military arsenal," Wolfsthal told Task & Purpose on Wednesday. "While we have a vast array of conventional military weapons and many means of delivery, none come even close to the explosive or destructive power associated with our nuclear arsenal."

"I will assume that this is consistent with the president consistent effort to say anything he does is better, smarter, stronger, bigger than anyone else, but is not based on any facts or real world assessment," Wolfstahl continued.

Trump has been known for making bellicose statements. Before his rapprochement with North Korean dictator Kim Jong Un, the president had threatened to subject the rogue communist regime to "fire and fury."

So we can all relax: there's no such thing as other kinds of weapons. It's all Mr. Trump just sounding off once again.

But I doubt that very much; it wasn't just Mr. Trump hinting at "something else", it was also that general in response to the reporter. And that raises another possibility that I'm not going to talk about, namely, the possibility that Mr. Wolfsthal is telling the truth, at least as far as he (and possibly President Obama) were made aware of it: no such

things existed in the US arsenal. And that might mean that they were kept deliberately out of the loop, while Mr. Trump was kept in that loop. And let's not forget the Chinese chemical plant explosion at Tianjin, and the suspiciously narrow and deep crater left by that event, which led me and others to speculate that perhaps one was looking at a "rod of God" attack.

## Part 3 — Building 7, and the 9/11 Event Revisited

At 5:20 PM, September 11th, 2001, a 47 story steel frame skyscraper in Manhattan underwent a swift, systematic, straight-down collapse. In a matter of seconds, the immense 600-foot tall structure was transformed into a small pile of rubble (and slag) lying almost entirely within the building's original footprint.

The building is variously known as Building 7, WTC 7, or 7 World Trade Center. Despite its address, it was across the street from the superblock containing the rest of the World TradeCenter, and was of a different architectural style and newer than the 6 other WTC buildings.

The cause of the collapse has never been determined. FEMA's Building Performance Study , the only government document that addressed the collapse of Building 7 in any detail, stated:

The specifics of the fires in WTC 7 and how they caused the building to collapse remain unknown at this time. ... Further research, investigation, and analyses are needed to resolve this issue.

By the time FEMA's report was published, the remains of Building 7 had been almost entirely destroyed, nearly all of the structural steel having been expeditiously removed and shipped to blast furnaces overseas. Without the physical evidence of the structural steel, such research, investigation, and analyses was impossible.

The Collapse of Building 7 was the third largest structural failure in World history, surpassed only by the collapses of the Twin Towers earlier that day. Fires are blamed for leveling Building 7, but fires have never caused the total or even partial collapse of a steel-frame high-rise, before or since September 11th.



Why, then, was there no serious investigation of the collapse of this building, and why does it remain virtually unknown to the American public? The most prominent 9/11 conspiracy theory today is that the collapse of the Twin Towers and 7 World Trade Center were the result of a controlled demolition rather than structural failure due to impact and fire.

Possible motives claimed by conspiracy theorists for such actions include justifying the invasions of <u>Afghanistan</u> and <u>Iraq</u> as well as <u>geostrategic</u> interests in the Middle East, such as <u>pipeline plans launched in the early 1990s</u> by <u>Unocal</u> and other oil companies.

×

What was in Building 7? — Building 7 was one of New York City's larger buildings. A sleek bronze-colored skyscraper with a trapezoidal footprint, it occupied an entire city block and rose over 600 feet above street level.

Built in 1985, it was formerly the headquarters of the junkbond firm Drexel Burnham Lambert, which contributed to the Savings and Loans collapse, prompting the \$500-billion taxpayer-underwritten bailout of the latter 1980s. At the time of its destruction, it exclusively housed government agencies and financial institutions. It contained offices of the IRS, Secret Service, and SEC.

One of the most interesting tenants was then-Mayor Giuliani's Office of Emergency Management, and its emergency command center on the 23rd floor. This floor received 15 million dollars worth of renovations, including independent and secure air and water supplies, and bullet and bomb resistant windows designed to withstand 200 MPH winds.

The Vertical Collapse of Building 7 — Building 7 collapsed in a nearly perfectly vertical motion at near the rate of free-fall. The first sign of the collapse is the falling of the penthouse, immediately followed by the falling of the whole facade, as seen from both the north and south. The middle of the building's north wall fell slightly faster than its edges.

In short, Building 7 imploded. Buildings are not designed to implode. They are designed to remain standing. To achieve a precisely vertical collapse, in which the remains of the buildingfall inward, is the objective of controlled

demolition. What was strange was that neither thermite nor excess jet engine fuel can actually get hot enough to slag concrete, found at the bottom of the debris.

After the building itself fell, there remained a single steel girder, some 617 feet high. Then it also began to fall, with video showing the steel vaporizing as it fell onto itself. Less than seven seconds after Building 7 began to implode, all that was left of the steel skyscraper was a rubble pile and concrete slag.

The Destruction of Building 7's Remains — Engineering is a science that melds theory and experience to create robust structures. Unintended structural failures are rare events that warrant the most careful scrutiny, since they test engineering theory.

That is why the NTSB carefully documents aircraft crash scenes, and preserves the aircraft remains, frequently creating partial reconstructions in hangars. If an investigation reveals a mechanical or design fault, the FAA usually mandates specific modifications of equipment or maintenance procedures system-wide, and future aircraft are designed to avoid the fault.

Building 7's rubble pile was at least as important as any archeological dig. It contained all the clues to one of the largest structural failures in history. Without understanding the cause of the collapse, all skyscrapers become suspect, with profound implications for the safety of occupants and for the ethics of sending emergency personnel into burning buildings to save people and fight fires.

There was no legitimate reason not to dismantle the rubble pile carefully, documenting the position of each piece of steel and moving it to a warehouse for further study. No one

was thought buried in the pile, since, unlike the Twin Towers, Building 7 had been evacuated hours before the collapse. The pile was so well confined to the building's footprint that the adjacent streets could have been cleared without disturbing it.

Yet, despite the paramount importance of the remains, they were hauled away and melted down as quickly as possible. The steel was sold to scrap metal vendors and most of it was soon on ships bound for China and India. Some of the smaller pieces and a few token large pieces of steel marked 'save' were allowed to be inspected at Fresh Kills landfill by FEMA's BPAT volunteers.

Dr. Frederick W. Mowrer, an associate professor in the Fire Protection Engineering Department at the University of Maryland, was quoted in the New York Times as saying:

I find the speed with which potentially important evidence has been removed and recycled to be appalling.

What Caused Building 7's Collapse? — Upon watching any of the many available videos, that Building 7's collapse showed all of the essential features of a controlled demolition. WTC 7 collapsed approximately 7 hours after the collapse of WTC 1. Preliminary indications were that, due to lack of water, no manual firefighting actions were taken by FDNY.

There is only one thing known in nature that can vaporize steel or slag concrete, that is a plasma.

If the steel were reinforced with fullerene carbon fibers, and the fullerenes contained deuterium, a controlled demolition could be orchestrated using laser triggering mechanisms (outlined earlier).

So now we have a new conspiracy theory, where this new weapon was experimentally deployed.

With the way media is controlled today we will likely never know the truth.

## A Space Elevator by 2050, using Carbon Nanotubes

Obayashi, a Japanese company, has announced they will have a space elevator up and running by the year 2050. If successful it would revolutionize space travel and potentially transform the global economy.

## OF ASTEROIDS AND ELECTROSTATIC GENERATORS

I'm always amazed at the ability of the "Gizars" to spot intriguing information, especially if it concerns technologies that don't normally "show up on the radar" of the lamestream corporate controlled media, nor, for that matter, on the radar of the alternative research field. But L.G.R. spotted this one, and passed it along.

And it's a doozie.

"It" in this case is a patent filing from 2017, rather blandly titled "Electromagnetic Field Generator and method to generate an electromagnetic field", interestingly enough the assignee is the US government via the Secretary of the Navy.

## <u>Eletcromagnetic Field Generator</u>

There are several intriguing things about this patent application, not the least of which are the first two paragraphs:

The invention described herein may be manufactured and used

by or for the Government of the United States of America for governmental purposes without payment of any royalties thereon or therefor.

And why would the USA want to do that? Well, paragraph two provides the answer:

To date there are more than 100,000 potentially dangerous asteroids (Near Earth Objects) which cross the earth's orbit, with only, 11,000 having been catalogued and currently tracked. earth will be impacted again and again; it is only a matter of time and circumstance. Therefore, there is a need for an effective method to deflect or destroy these potentially dangerous asteroids. (Emphasis added)

That, of course, reveals itself to be the purpose of the patent, and of course, if you're like me, you've probably also noted the more or less "coincidental" appearance of this patent within a year of the Trump Administration's creation of a "space force". After reviewing a few other methods of deflecting asteroids in paragraph three, the patent description observes that "the techniques described... would only affect 'small' asteroids, on the average diameter levels of approximately 100 meters." Implication: we need something that can take care of the really big ones, and that is not subject to the hazards of kinetic targeting (with its chances for a "miss") and the resulting fragmentation of the asteroid, which could be as dangerous as the asteroid itself as many potential impacts would replace just one.

And thus, "the present invention is directed to an electromagnetic field generator and a method to generate an electromagnetic field with the needs enumerated above," i.e., something strong enough to "deflect or destroy" a big asteroid. And when you read the details in the filing, you might, like me, be thinking that "this sounds vaguely familiar" and that it might "ring a Bell."

Oh, and in case you missed it, it's also a handy thing to have around for some "other" purposes:

It is a feature of the present invention to provide a method and apparatus for generating an impenetrable defensive shield to Sea and Land as well as Space-based military and civilian assets, protecting these assets from such threats as Anti-Ship Ballistic Missiles, Radar Evading Cruise Missiles, Top Attack for main battle tanks...

Oh.... did we mention, it's capable of a little solar manipulation as well?:

...as well as counteracting the effects of solar-induced Coronal Mass Ejections... (Paragraph 0012)

Presumably it will do all this by generating electromagnetic fields, which, to accomplish all these feats, would have to be extraordinarily strong, but not to worry, because the "the design of energy generation machinery with power output levels much higher than those currently achievable by conventional means, is made possible with this invention." (Paragraph (0012)

At this point, the patent goes on to outline how it's going to do all of this, and lo and behold, it does so by spinning a plasma, utilizing shells in a sphere of peizoelectric ceramics doped with radioactive materials. Of course, I'm oversimplifying, but the end result of all of this is that this creates the Mossbauer Effect of vibrationally stimulated and cohered releases of gamma rays. All of this, according to paragraph 30, will generate field strengths per square meter of (get this) 10,000,000,000,000,000,000,000,000 watts. That's ten septillion to one hundred octillion watts.

Per square meter.

I could go on, but you get the idea.

But what emerges from this bizarre list? What's the common theme? For one thing, space, and its manipulation at all levels, from "higher dimensionalities" to "nonlocality", quantum entanglement for communications, traversible wormholes and programmable metamaterials (useful for long distance space ships able to make instant repairs against micro-meteoric bombardment). There's even a bow to the late 1950s Brookings Report, with the mention of "magnetohydrodynamics", a term that, to my knowledge, first appears in the Brookings report. And invisibility? We all know the story of the Philadelphia Experiment. Engineering the fabric of space-time? That's another nifty way to accomplish invisibility, traverse wormholes, and manipulate higher dimensionalities. (Reading this list makes one wonder if British hacker Gary McKinnon, who claims to have uncovered evidence of a secret American "space fleet", might have uncovered something whose mere existence pointed in the direction of these types of papers.)

In other words, if one views these papers from a wide and long view, one discovers that their subject matter extends back some decades to the Brookings Report, to the work of T.T. Brown, Gabriel Kron, and others, and that that work never stopped.

And there's something else that emerges, besides the obvious determination to dominate space in every way and at every level, from materials science to the ability to manipulate the fabric of spacetime itself. This list of papers, if one thinks about them in a certain way, seems oddly to corroborate the concerns of the alternative research field: UFOs, 5G and its biological effects, microwave weapons, California fires and pulverized trade center buildings on 9/11... it all seems to be here...

And there's one more thing... Developing this type of technology, assuming the papers represent something more than just mere "brainstorming", will require a lot of money over several decades. Something, say, on the order of \$21,000,000,000,000? If money is missing, this may be one very strong reason why...
