



This is the **THIRD** Proclamation of Arikinui Ripekatangi of many tribes and subtribes of our Supreme Sovereign Nation of New Zealand, Leader and Prime Minister of the Wakaminenga Maori Government of Aotearoa New Zealand.

WHEREAS, on October 28th, 1835, the sovereign independence of the people of New Zealand was declared, in He Wakaputanga O te Rangatiratanga O Nu Tireni/Declaration of Independence 1835 and;


WHEREAS, that Declaration of Independence is unextinguished and settled under international law and;

WHEREAS, This unextinguished international law declares in *Article 2,..."* that all sovereign power and authority within our Territories resides entirely and exclusively in the Hereditary Chiefs and Heads of Tribes

in their Collective Capacity who also declare that they will not permit any legislative authority separate from themselves to exist, nor any function of governments to be exercised within the said territories unless by persons appointed by us and acting under the authority of laws enacted by us in our Congress assembled." This means any effort to form such an agreement is void ab initio in our jurisdiction." And;

WHEREAS, On May 21st, 2022 and March 3rd, 2022 The Wakaminenga Maori Government notified the Executive Board of the World Health Assembly (WHO) and yourself, Tedros Adhanom Ghebreyesus, acting in the role of Director General of the WHO and the person acting in the role of President of the European Council that we do not consent in any shape or form to any type of international pandemic treaty under the WHO or its assembly. Any such construct shall be void ab initio, and;

WHEREAS This Third Notice reiterates those first and second notifications and is made in accordance with our unextinguished sovereign written constitution of He Wakaputanga 1835 the Declaration of Independence of the Hereditary Chiefs and Heads of Tribes of the United Tribes of Nu Tireni New Zealand, and;


WHEREAS The New Zealand Crown government represented by Christapher Luxon has no lawful basis since it has never been given consent to rule, reign and govern in our country by the sovereign de jure governing body of Te Wakaminenga o Te Rangatiratanga, the Hereditary Chiefs and Heads of Tribes of the Congress of the United Tribes of New Zealand, and;

WHEREAS, since neither consent nor approval to apply the rule of the WHO within the territories of the United Tribes of New Zealand/Nu Tireni has been granted by the Hereditary Chiefs and Heads of Tribes of the Congress of the United Tribes of New Zealand no measures authorised by you, Tedros Adhanom Ghebreyesus, or any other representative of the WHO & UN/WEF, or any foreign institution has any legal standing over any member of the Wakaminenga Maori Government

WHEREAS the will of the People of the United Tribes of New Zealand/Nu Tireni is that the rule of law through application of Tikanga within this land is restored within the territories of the United Tribes of New Zealand/Nu Tireni. Furthermore, they want lawful governance restored to them. This has been given effect by the establishment of Te Kooti Wakanga/Court of Justice. Te Kooti Wakanga has received the decision of a jury, representative of the People, that various officials of the New Zealand Crown Government and individuals of the New Zealand 53rd Parliament, including Christopher Luxon, were guilty of abrogating the authority and power of Te Wakaminenga Congress,

WHEREAS those who acquired legislative authority and then mis-used it to facilitate their response to the COVID-19 pandemic are responsible for causing harm, injury, and death to New Zealanders. They were following the decision made by yourself on March 11, 2020, to declare a pandemic upon the world and agreed to import the mRNA biotechnology into New Zealand without the consent of The Wakaminenga Congress. This was in deliberate contravention of a cease-and-desist notice from Te Wakaminenga not to import the mRNA biotechnology into New Zealand, and;

THEREFORE, you, Tedros Adhanom Ghebreyesus are hereby notified that any agreement between the corporate entity of New Zealand Crown Government and the WHO or the Executive Board of the WHO Assembly is subject to review by the sovereign people of Aotearoa Nu Tireni/New Zealand and the administrative arm, Wakaminenga Maori Government of Aotearoa Nu Tireni/New Zealand duly constituted under the internationally recognised Declaration of Independence, Te Wakaputanga 1835, Constitution of New Zealand, and;



who have abrogated sovereignty by warring on the Maori Nation, passing unlawful legislation, bribing Maori to cede their sovereignty by way of unlawful treaty settlements and unlawfully claiming lands and resources.

This notice serves to notify you Tedros Adhanom Ghebreyesus, acting in the role of Director General of WHO and the Executive Board of the World Health Assembly (WHO) and any other persons engaged in actions to further policies of depopulation that under settled international law and our unextinguished settled law of Tikanga and Whakaputanga 1835, that **We** do not consent to the implementation of the international treaty on pandemic prevention and preparedness upon our Sovereign Independent Nation of Aotearoa Nu Tireni New Zealand and **We** will not be bound by any construct devised by any organisation but ourselves.

Any breach of this Cease-and-Desist Order constitutes a violation of our sovereign law and will be prosecuted under international law and our Maori Law jurisdiction of Tikanga and He Wakaputanga the Constitution of Nu Tireni New Zealand. Those found guilty of crimes of genocide and crimes against humanity will be liable for penalties determined by Hou Hunga Rongo that may include imprisonment and the surrender of up to 100 percent of one's assets.
